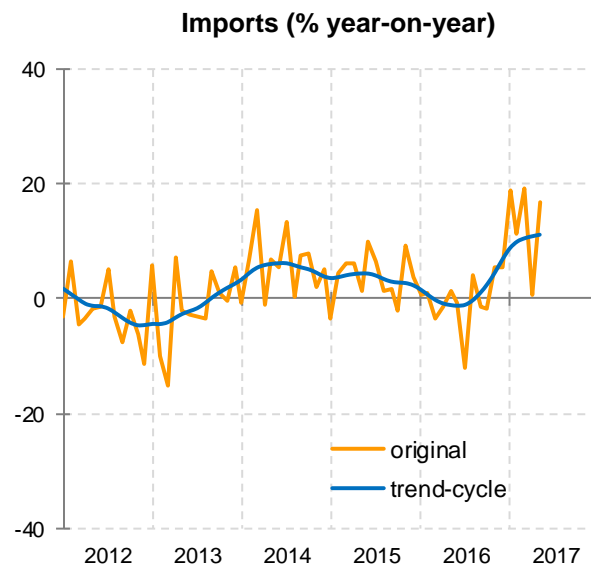
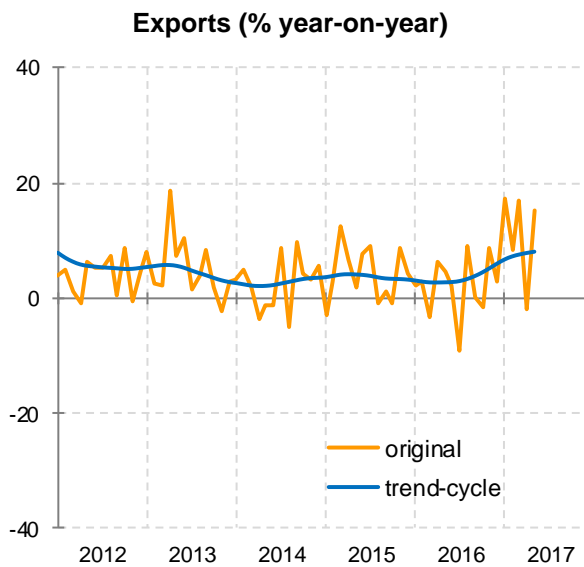

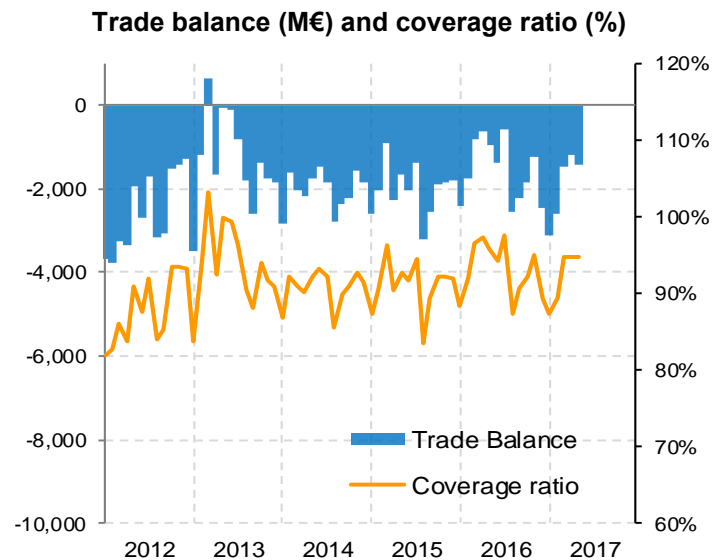


## MAY 2017

In May 2017, **Spain's exports increased by 15.2%** year-on-year in nominal terms to 25,359.1 million euros, whereas **imports went up by 16.7%** to 26,790.1 million euros. With seasonally adjusted data, exports increased by 13.2% year-on-year and imports by 14.8%. In **real terms**, exports rose by 14.2% year-on-year, as export prices expanded by 0.9%, and imports augmented by 10.5%, as import prices augmented by 5.6%. In nominal terms on a **month-on-month** basis, exports advanced by 16.3% and imports by 16.5%. With seasonally adjusted data, exports increased by 4.0% month-on-month and imports by 4.3%.

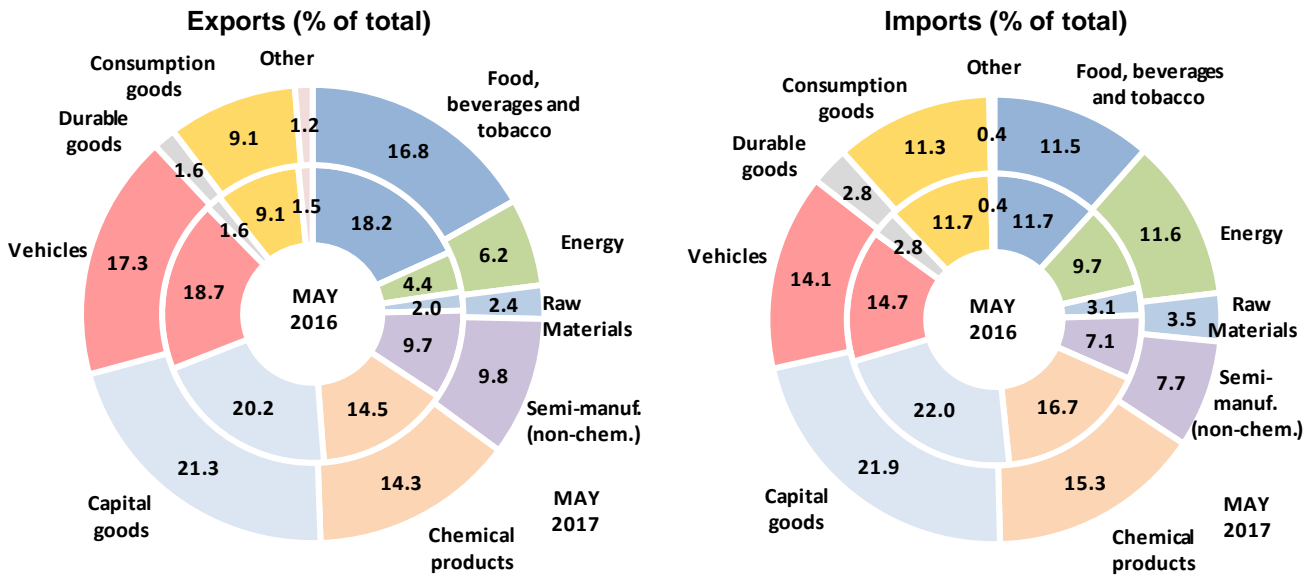


Spain's **trade balance** registered a deficit of 1,431 million euros, up from a deficit of 940.9 million euros in May 2016 (provisional data). The export/import **coverage ratio** reached 94.7%, 1.2 percentage points lower than in the same month of 2016 (95.9% in May 2016 with provisional data). The **non-energy trade balance** reached a surplus of 109.3 million euros, down from a surplus of 322.4 million in the same month of 2016. The **energy trade deficit** increased by 21.9% year-on-year to 1,540.4 million euros (compared to a deficit of 1,263.3 million euros in May 2016).



### Sectoral data

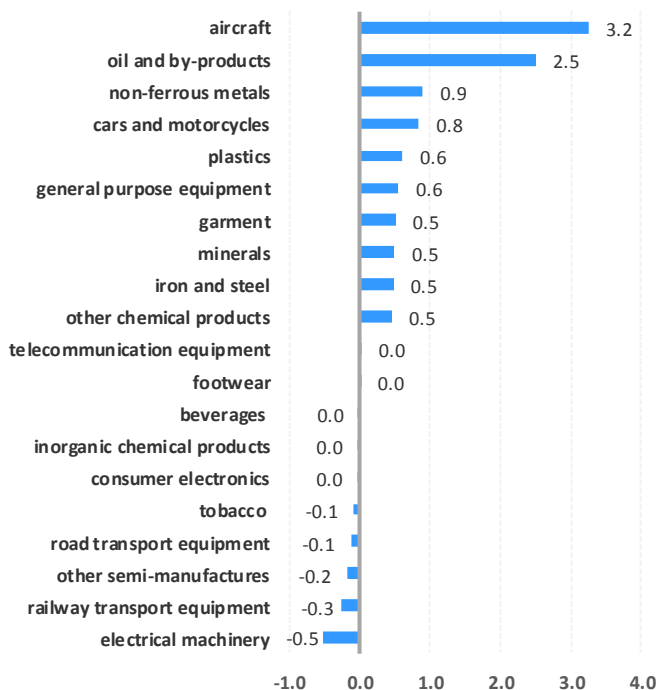
Spain's **main exporting sectors** in May 2017 were *capital goods* (representing 21.3% of total exports and increasing by 21.5% year-on-year), *vehicles* (17.3% of total, growing by 6.8%), *food, beverages and tobacco* (16.8% of total, increasing by 6.3%) and *chemical products* (14.3% of total, growing by 14.0%).



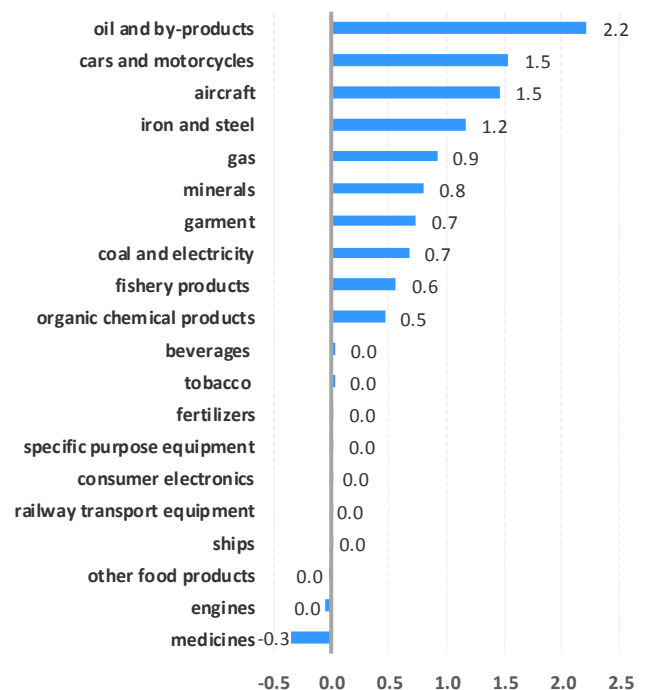
The most significant sectors of Spain's imports were *capital goods* (representing 21.9% of total imports and advancing by 16.4% year-on-year), *chemical products* (15.3% of total, increasing by 6.6%), *vehicles* (14.1% of total, advancing by 12.0%) and *energy* (11.6% of total, rising by 39.1%).

Among subsectors, the largest contributions to the annual change in Spain's exports in May 2017 (up by 15.2%) came from *aircraft* (3.2 points), *oil and by-products* (2.5 points) and *non-ferrous metals* (0.9 points). The major negative contributions corresponded to *electrical machinery* (-0.5 points), *railway transport equipment* (-0.3 points) and *other semi-manufactures* (-0.2 points).

Exports (top/bottom contrib. to annual change, p.p.)



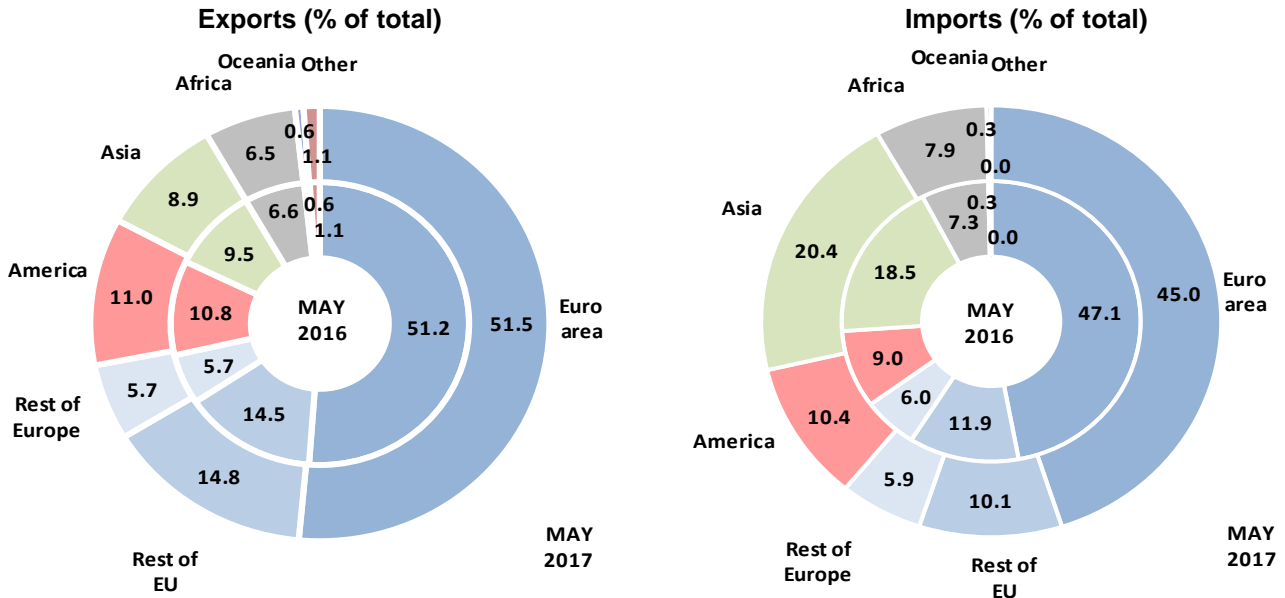
Imports (top/bottom contrib. to annual change, p.p.)



The subsectors with the most positive contribution to the annual change in Spain's imports in May 2017 (up by 16.7%) were *oil and by-products* (2.2 points), *cars and motorcycles* (1.5 points) and *aircraft* (1.5 points). The major negative contribution corresponded to *medicines* (-0.3 points).

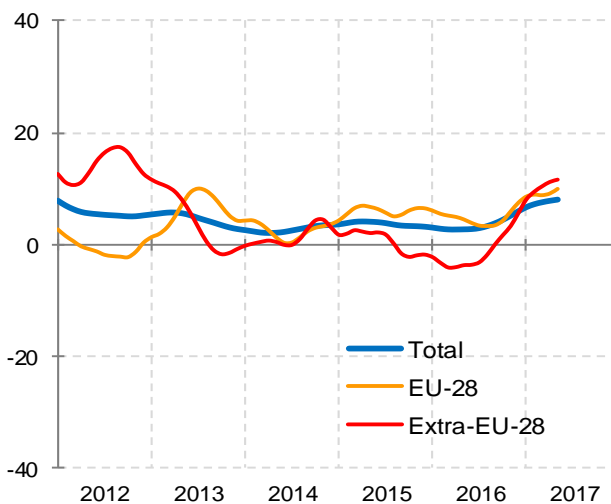
## Geographic data

Exports to the **European Union** accounted for 66.3% of total exports in May 2017 (up from 65.7% in May 2016) and went up by 16.2% year-on-year. Exports to the **euro area** accounted for 51.5% (up from 51.2% in May 2016) and went up by 15.9%. Exports to **non-EU countries** accounted for 33.7% of total exports (down from 34.3% in May 2016) as they expanded by 13.2% year-on-year.

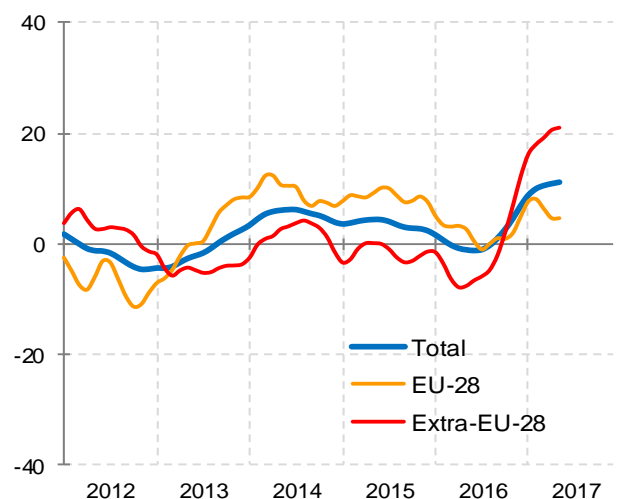


Imports from the **European Union** accounted for 55.1% of total imports in May 2017 (down from 59.0% in May 2016) and advanced by 9.0% year-on-year. Imports from the **euro area** represented 45.0% (down from 47.1% in May 2016) and increased by 11.7%. Imports from **non-EU countries** accounted for 44.9% of total imports in May 2017 (up from 41.0% in May 2016) as they increased by 27.8% year-on-year.

### Exports EU and extra-EU (% y-o-y trend-cycle)



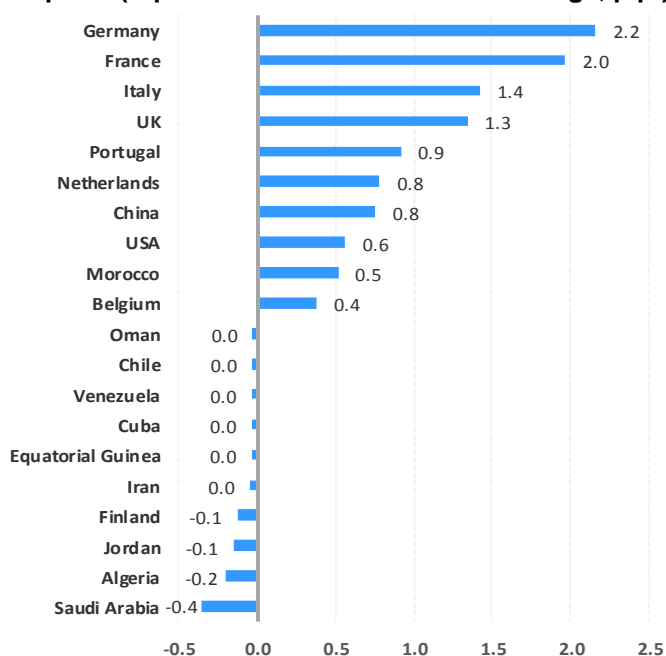
### Imports EU and extra-EU (% y-o-y trend-cycle)



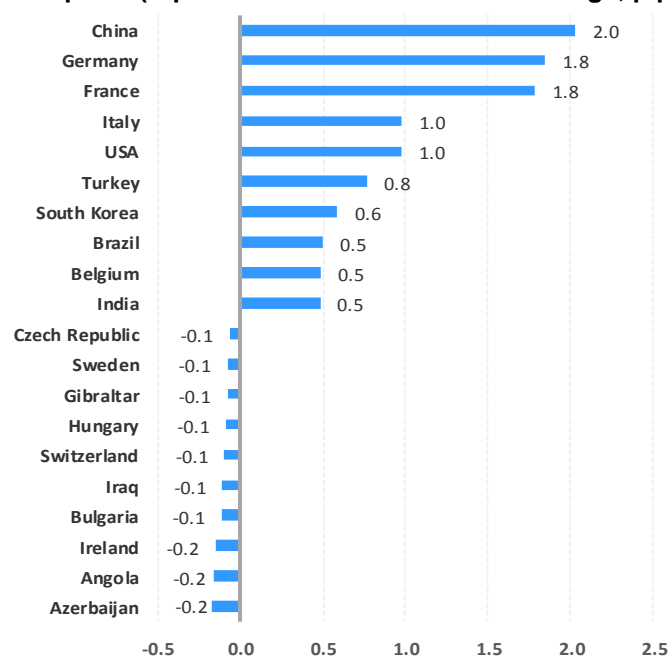
**Trade balance with the European Union** showed in May 2017 a surplus of 2,050.7 million euros (up from a surplus of 918.3 million in May 2016) and a surplus of 991.7 million euros with the euro area (462.6 million surplus in May 2016). **Trade deficit with the rest of the world** increased to 3,481.7 million euros (from a deficit of 1,859.2 million euros in May 2016).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in May 2017 (up by 15.2%) were Germany (2.2 percentage points), France (2.0 points), Italy (1.4 points) and the United Kingdom (1.3 points). Those destinations with the largest negative contributions were Saudi Arabia (-0.4 points), Algeria (-0.2 points), Jordan (-0.1 points) and Finland (-0.1 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in May 2017 (up by 16.7%) were China (2.0 percentage points), Germany (1.8 points), France (1.8 points) and Italy (1.0 points). The destinations with the largest negative contributions were Azerbaijan (-0.2 points), Angola (-0.2 points), Ireland (-0.2 points) and Bulgaria (-0.1 points).

### **International data**

**In comparison to other geographical areas**, Spain's exports of goods went up by 15.2% year-on-year in May, a higher increase than that of the euro area (14.0%) and the European Union (13.8%). Within the European Union, exports also increased in Germany (14.1%), France (9.2%), Italy (13.1%) and in the United Kingdom (25.3%). Outside the European Union, the United States exports increased by 7.0%, China's by 5.5% and Japan's by 14.9%.



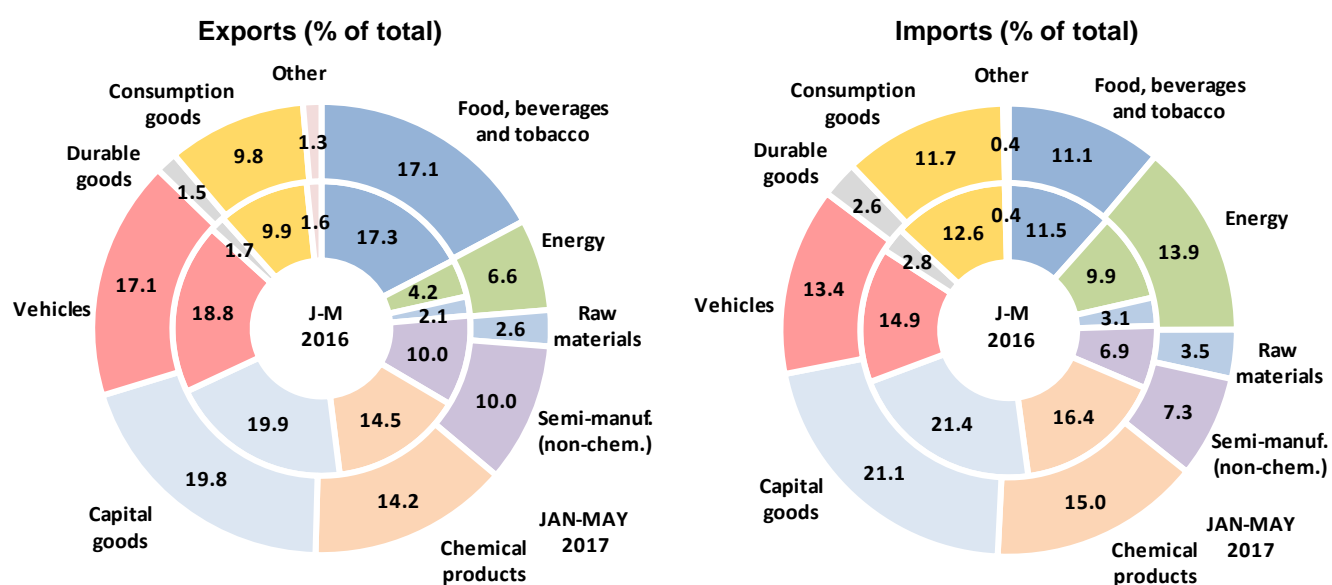
## JANUARY – MAY 2017

**Spain's exports grew by 10.9%** in the period of January-May 2017 compared to the same period of 2016 to 116,896.8 million euros and imports increased by 13.3% year-on-year to 126,726 million euros. In real terms, exports rose by 10.1% year-on-year, as export prices advanced by 0.8%, and imports advanced by 6.0% year-on-year, as import prices rose by 6.9%.

**Spain's trade deficit** increased to 9,829.2 million euros compared to the same period of 2016 (deficit of 6521.7 million euros). The export/import **coverage ratio** reached 92.2%, 2.0 percentage points lower than in the same period of 2016 (94.2%, provisional data). The **non-energy trade balance** reached a surplus of 89.3 million euros, compared to a surplus of 132.6 million euros in January-May 2016, whereas the **energy trade deficit** increased by 49.1% year-on-year to 9,918.5 million euros.

### Sectoral data

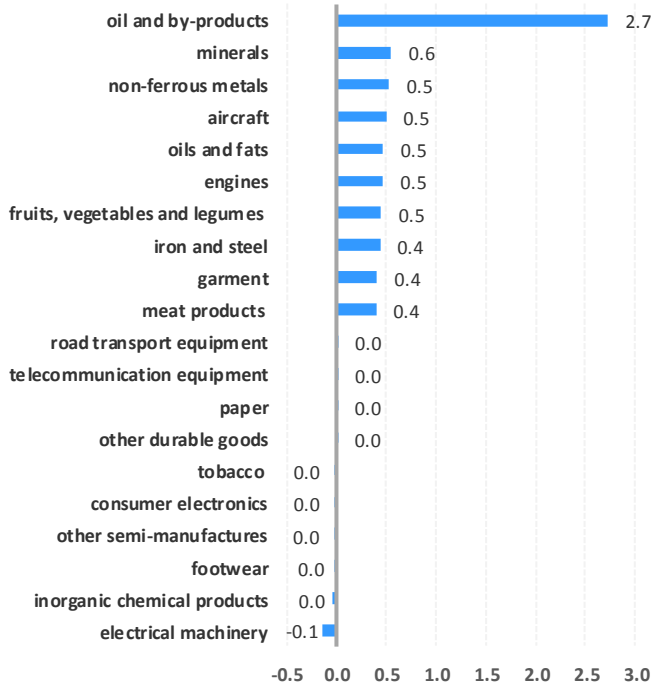
Spain's **main exporting sectors** in the period of January-May were *capital goods* (representing 19.8% of total exports, growing by 10.2% year-on-year), *food, beverages and tobacco* (17.1% of total, growing by 9.8%), *vehicles* (17.1% of total, advancing by 0.9%) and *chemical products* (14.2% of total, advancing by 8.8%).



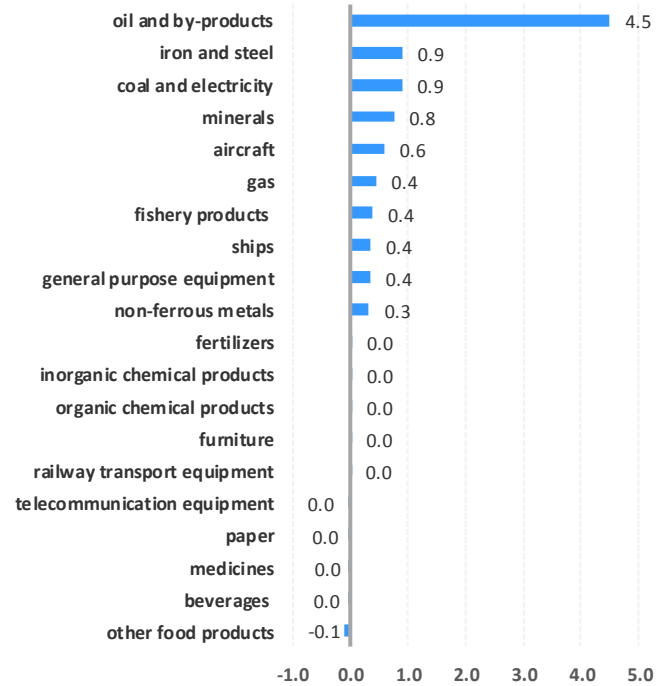
The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 21.1% of total and growing by 11.9% year-on-year), *chemical products* (15.0% of total imports, growing by 3.5%), *energy* (13.9% of total imports, surging by 59.1%) and *vehicles* (13.4% of total imports, increasing by 2.1%).

Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 10.9%) were *oil and by-products* (2.7 percentage points), *minerals* (0.6 points) and *non-ferrous metals* (0.5 points). On the other hand, the largest negative contribution by subsectors corresponded to *electrical machinery* (-0.1 points).

**Exports (top/bottom contrib. to annual change, p.p.)**



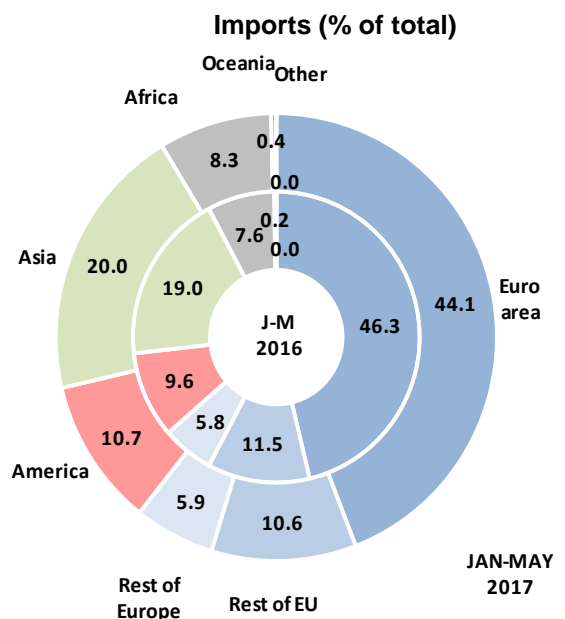
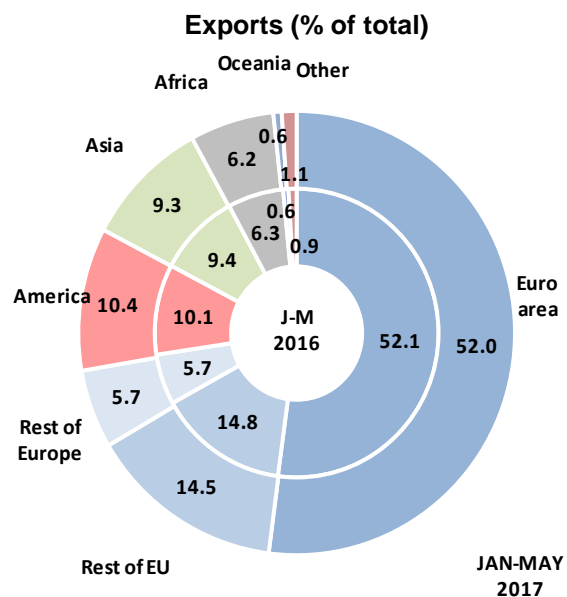
**Imports (top/bottom contrib. to annual change, p.p.)**



The **subsectors with most positive contributions** to the annual change in Spain's imports in January-May 2017 (up by 13.3%) were *oil and by-products* (4.5 points), *iron and steel* (0.9 points) and *coal and electricity* (0.9 points). The major negative contribution corresponded to *other food products* (-0.1 points).

**Geographic data**

Exports to the **European Union** accounted for 66.5% of total exports in the period (down from 66.9% in the same period of 2016) and expanded by 10.3% year-on-year, while exports to the **euro area** accounted for 52.0% of total (52.1% in the same period of 2016) and advanced by 10.8%. Exports to the **rest of the world** accounted for 33.5% of total exports (33.1% in the same period of 2016) and rising by 12.3%.



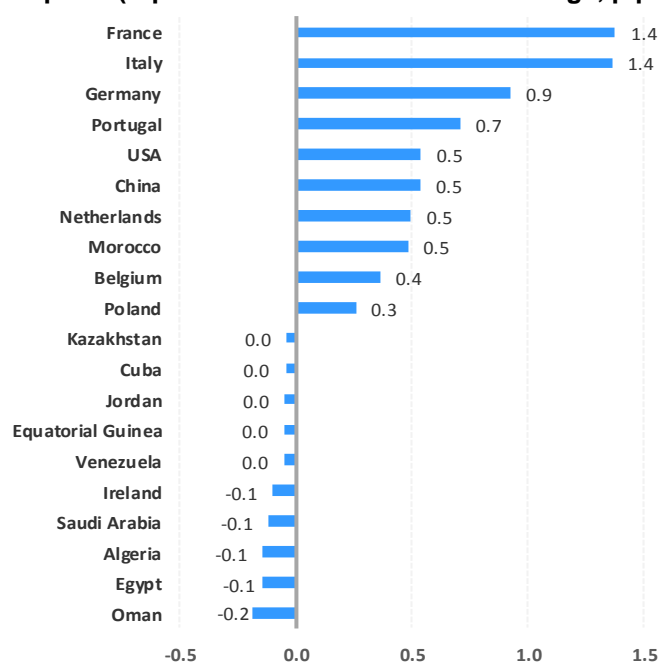
Imports from the **European Union** accounted for 54.8% of total imports in January-May 2017 (down from 57.8% in the same period of 2016) and increased by 7.3% year-on-year. Imports from the **euro area** accounted for 44.1% (46.3% in the same period of 2016) and expanded by 8.1%. Imports from the **rest of**

**the world** accounted for 45.2% of total imports (42.2% in the same period of 2016) and went up by 21.4% year-on-year.

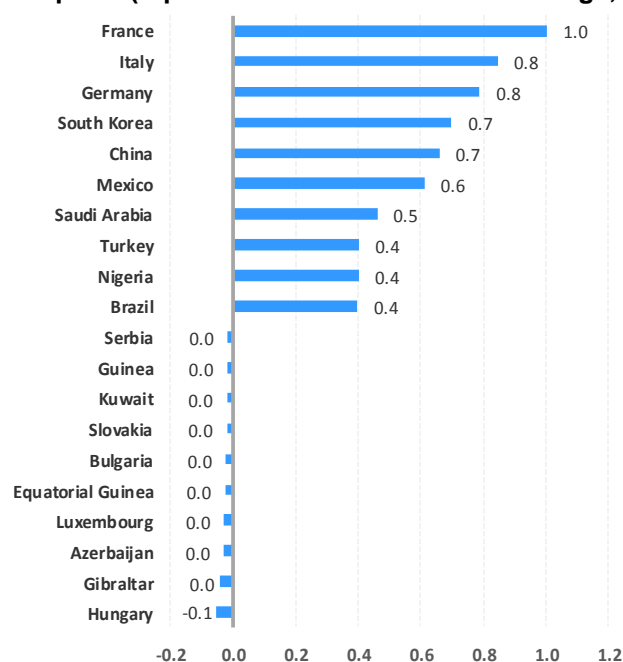
**Spain's trade surplus with the European Union and with the euro area** increased to 8,404.4 million euros and to 4,910.2 million euros respectively, up from surpluses of 5,876.6 million and 3,155 million euros in the same period of the previous year. The **trade deficit with the rest of the world** increased by 47.1% year-on-year to 18,233.5 million euros.

In terms of **contribution to the annual change of exports** (up by 10.9%), the main contributions were those of France (1.4 percentage points), Italy (1.4 points), Germany (0.9 points) and Portugal (0.7 points). Those destinations with the largest negative contributions were Oman (-0.2), Egypt (-0.1 points), Algeria (-0.1 points) and Saudi Arabia (-0.1 points).

**Imports (top/bottom contrib. to annual change, p.p.)**



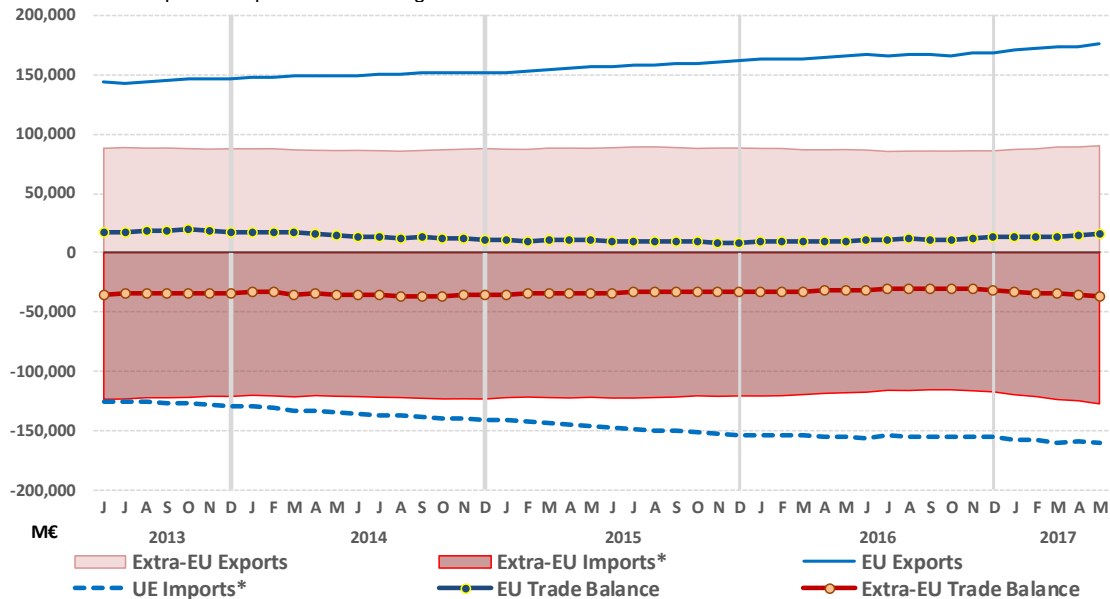
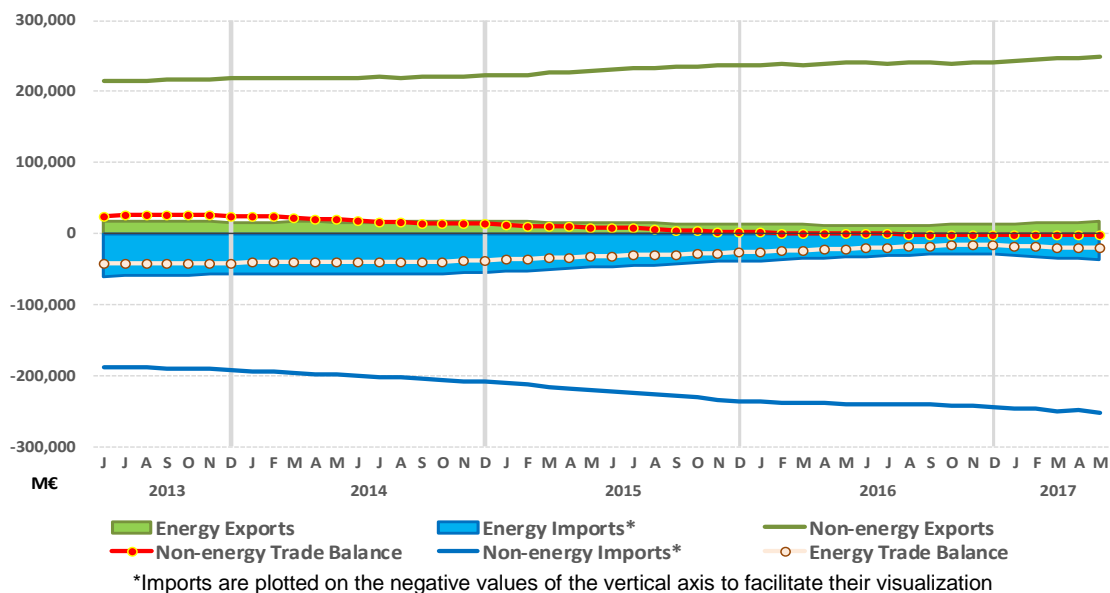
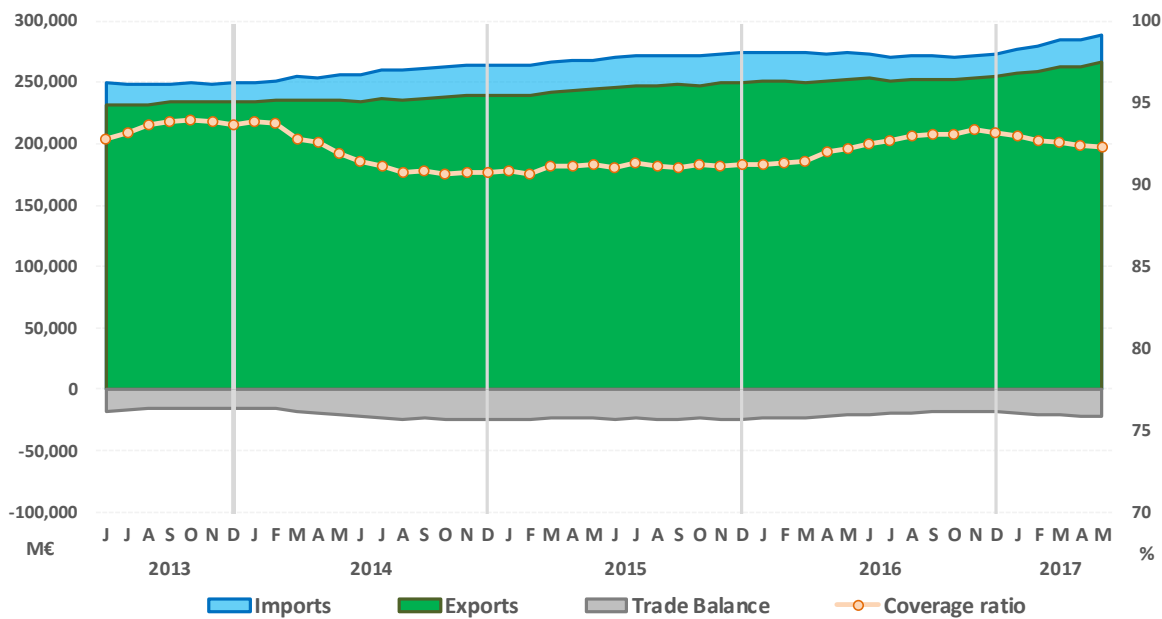
Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's imports in the period (up by 13.3%) were France (1.0 percentage points), Italy (0.8 points), Germany (0.8 points), and South Korea (0.7 points). The destination with the largest negative contribution was Hungary (-0.1 points).

In the period January-May, the number of **Spanish exporters** advanced by 1.4% year-on-year to 96,461 exporters, out of which 29,353 had already exported at least 50,000 euros worth of goods in the period, 1.6% more than in the same period of 2016. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 46,085 in the period, 47.8% of total exporters and 1.8% more than in the same period of 2016. Their exports reached 111,495.9 million, 95.4% of total exports and 11.1% more than in the same period of the previous year.

## **International data**

**In comparison to other geographical areas**, Spain's exports of goods grew by 10.9% year-on-year in the period of January-May 2017, a higher rate than those attained by the euro area (8.6%) and the European Union (8.7%). Within the European Union, exports also increased in Germany (7.2%), France (3.6%), Italy (8.0%) and the United Kingdom (19.0%). Outside the European Union, the United States exports increased by 6.8%, China's by 4.5% and Japan's by 9.4%.
