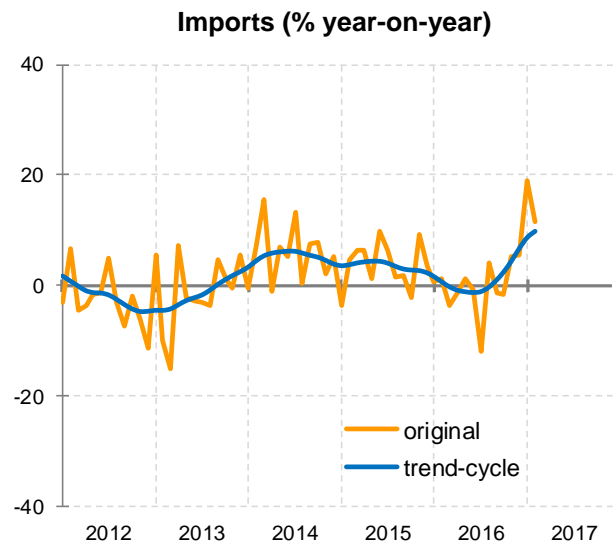
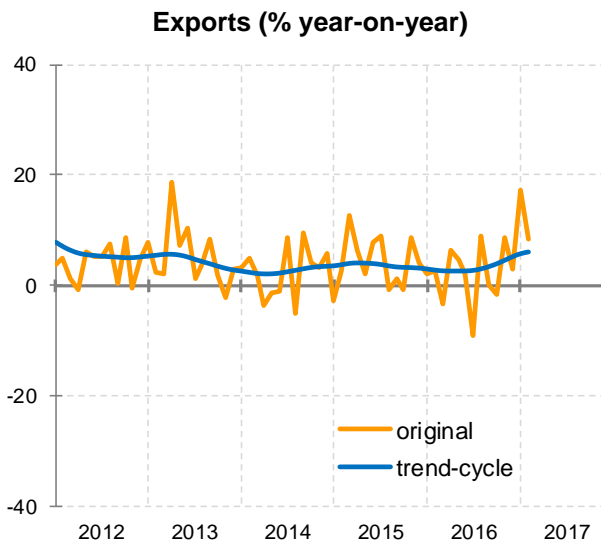

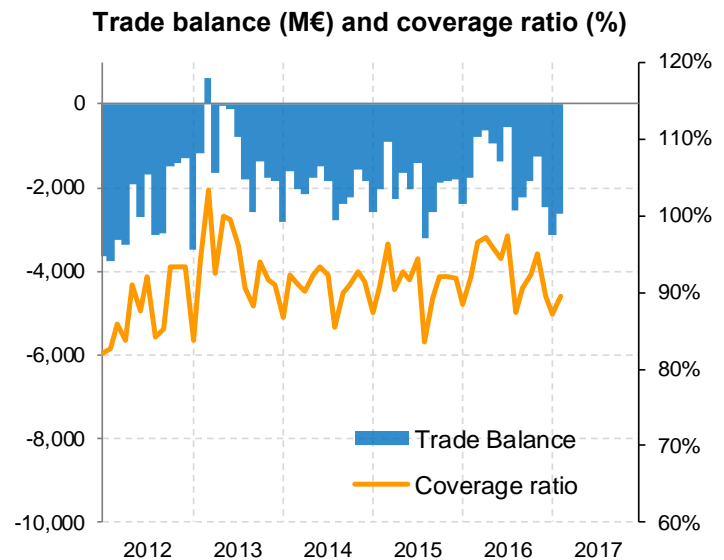


## FEBRUARY 2017

In February 2017, **Spain's exports advanced by 8.3%** year-on-year in nominal terms to 22,075.6 million euros, whereas **imports increased by 11.4%** to 24,681.6 million euros. With seasonally adjusted data, exports grew by 10.1% year-on-year and imports by 13.2%. In **real terms**, exports advanced by 8.4% year-on-year, as export prices declined by 0.1%, and imports increased by 6.1%, as import prices rose by 5.0%. In nominal terms on a **month-on-month** basis, exports expanded by 3.0% and imports by 0.4%. With seasonally adjusted data, exports dropped by 1.8% month-on-month and imports increased by 0.5%.

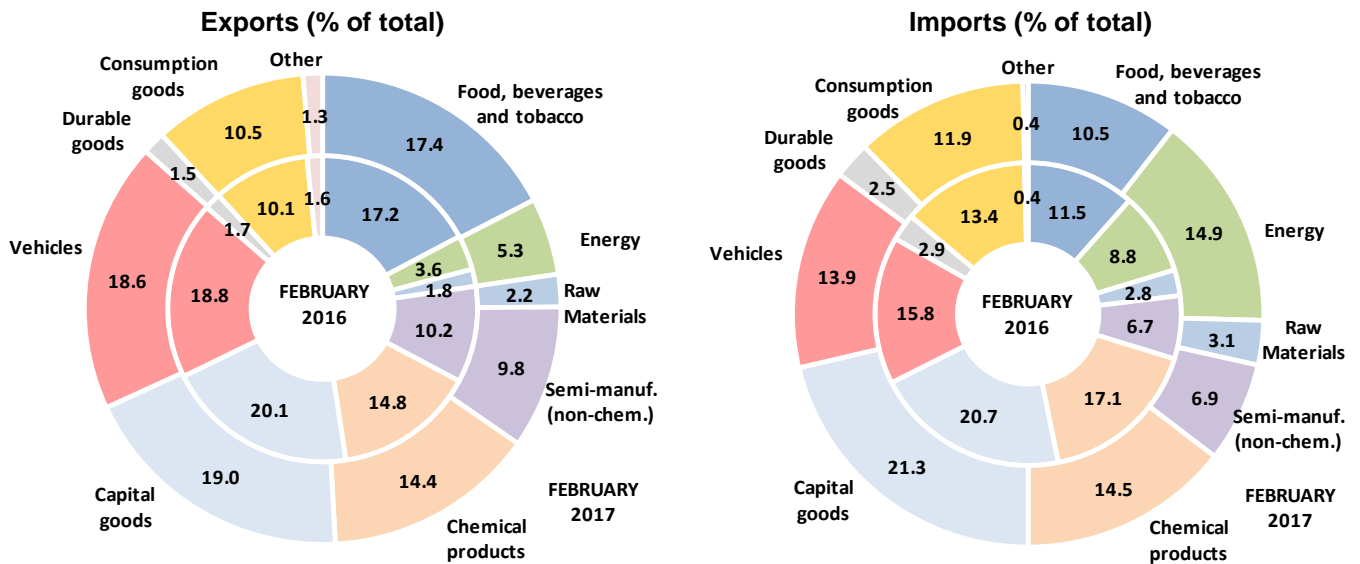


Spain's **trade balance** registered a deficit of 2,606.0 million euros, up from a deficit of 1,761.0 million euros in February 2016 (provisional data). The export/import **coverage ratio** reached 89.4%, 2.7 percentage points lower than in the same month of 2016 (92.1% in February 2016 with provisional data). The **non-energy trade balance** reached a deficit of 85.2 million euros, from a deficit of 559.2 million in the same month of 2016. The **energy trade deficit** doubled year-on-year to 2,520.8 million euros (compared to a deficit of 1,201.9 million euros in February 2016).



### Sectoral data

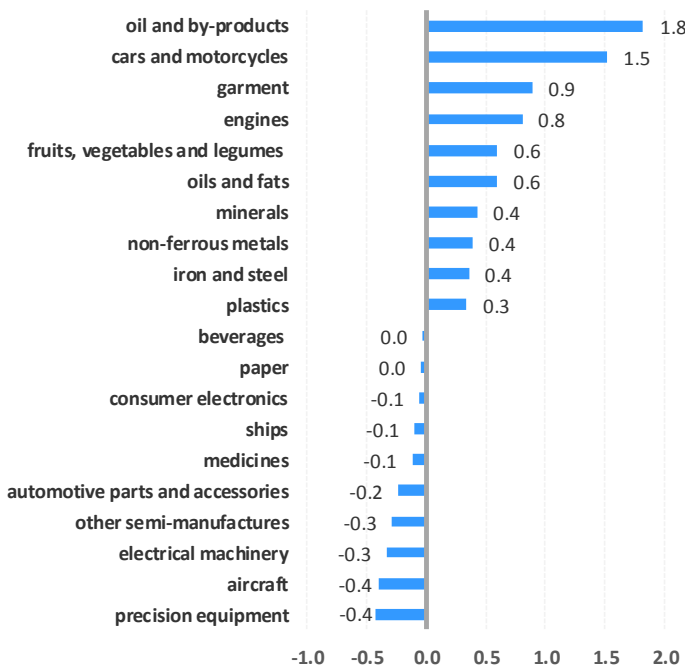
Spain's **main exporting sectors** in February 2017 were *capital goods* (representing 19.0% of total exports and growing by 2.0% year-on-year), *vehicles* (18.6% of total, rising by 6.8%), *food, beverages and tobacco* (17.4% of total, advancing by 9.3%) and *chemical products* (14.4% of total, rising by 5.9%).



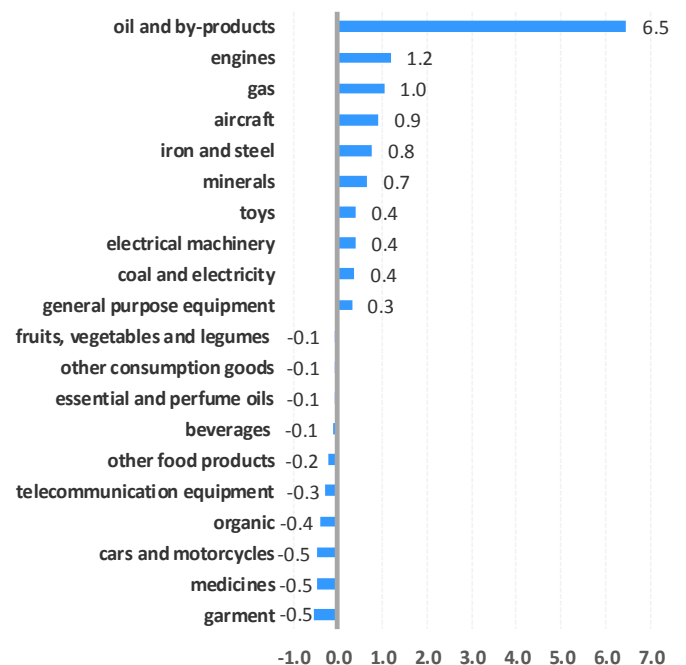
The **most significant sectors of Spain's imports** were *capital goods* (representing 21.3% of total imports and advancing by 14.9% year-on-year), *energy* (14.9% of total, rising by 89.7%), *chemical products* (14.5% of total, shrinking by 5.2%) and *vehicles* (13.9% of total, falling by 1.7%).

Among **subsectors, the largest contributions** to the annual change in Spain's **exports** in February 2017 (up by 8.3%) came from *oil and by-products* (1.8 points), *cars and motorcycles* (1.5 points) and *garment* (0.9 points). The major negative contributions corresponded to *precision equipment* (-0.4 points), *aircraft* (-0.4 points) and *electrical machinery* (-0.3 points).

Exports (top/bottom contrib. to annual change, p.p.)



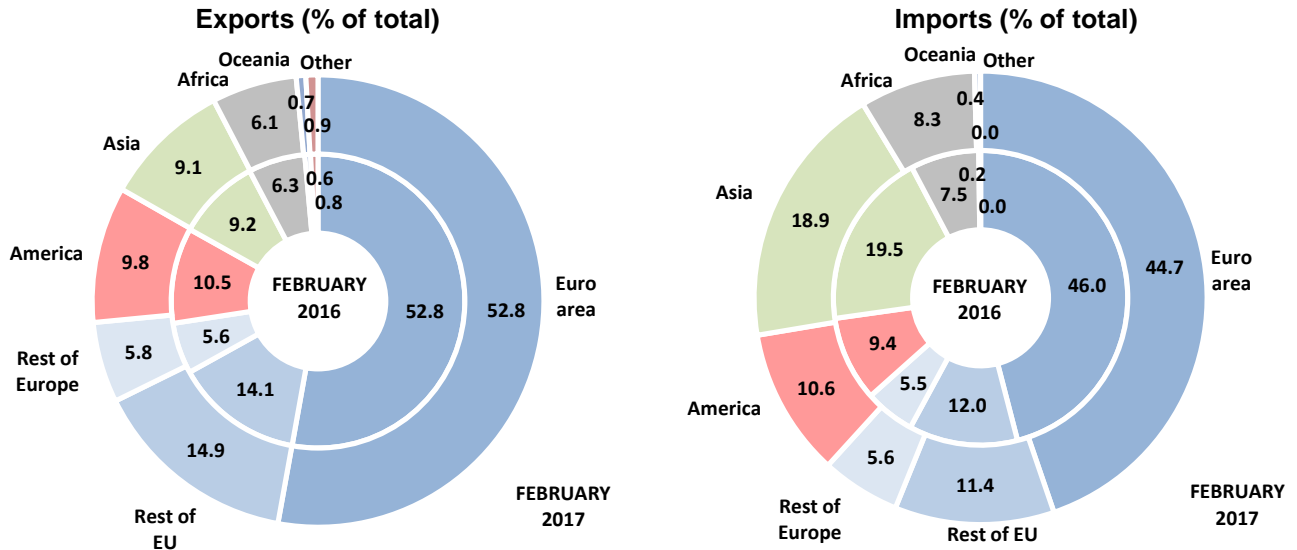
Imports (top/bottom contrib. to annual change, p.p.)



The **subsectors with the most positive contribution** to the annual change in *Spain's imports* in February 2017 (up by 11.4%) were *oil and by-products* (6.5 points), *engines* (1.2 points) and *gas* (1.0 points). The major negative contributions corresponded to *garment* (-0.5 points), *medicines* (-0.5 points) and *cars and motorcycles* (-0.5 points).

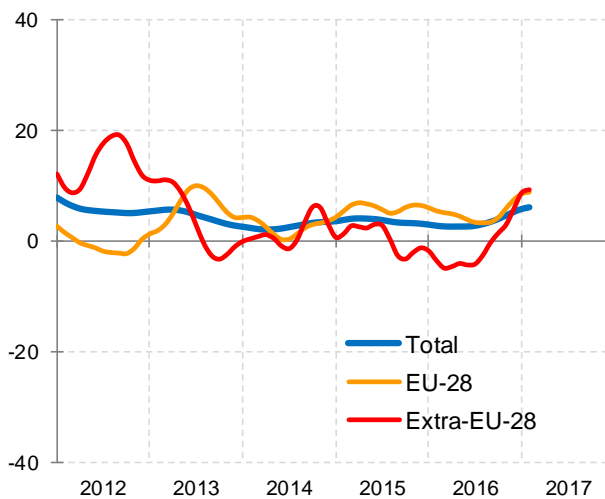
## Geographic data

Exports to the **European Union** accounted for 67.7% of total exports in February 2017 (up from 67.0% in February 2016) and increased by 9.5% year-on-year. Exports to the **euro area** accounted for 52.8% (same value as in February 2016) and advanced by 8.3%. Exports to **non-EU countries** accounted for 32.3% of total exports (down from 33.0% in February 2016) as they augmented by 5.8% year-on-year.

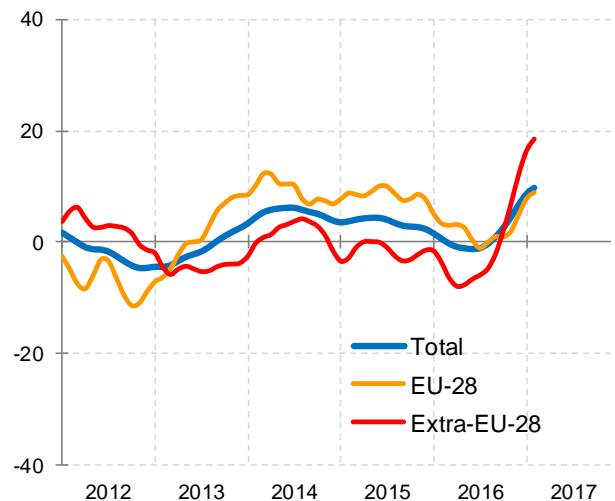


Imports from the **European Union** accounted for 56.1% of total imports in February 2017 (down from 57.9% in February 2016) and advanced by 8.0% year-on-year. Imports from the **euro area** represented 44.7% (down from 46.0% in February 2016) and went up by 8.5%. Imports from **non-EU countries** accounted for 43.9% of total imports in February 2017 (up from 42.1% in February 2016) as they augmented by 16.1% year-on-year.

Exports EU and extra-EU (% y-o-y trend-cycle)



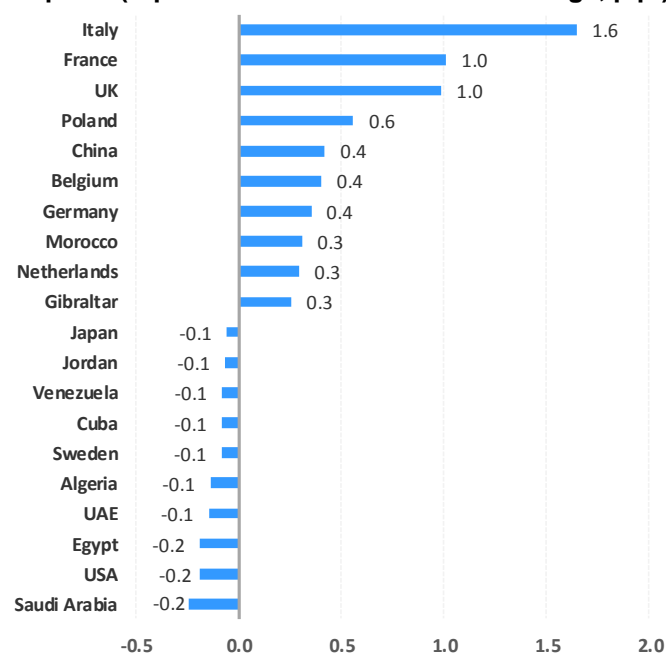
Imports EU and extra-EU (% y-o-y trend-cycle)



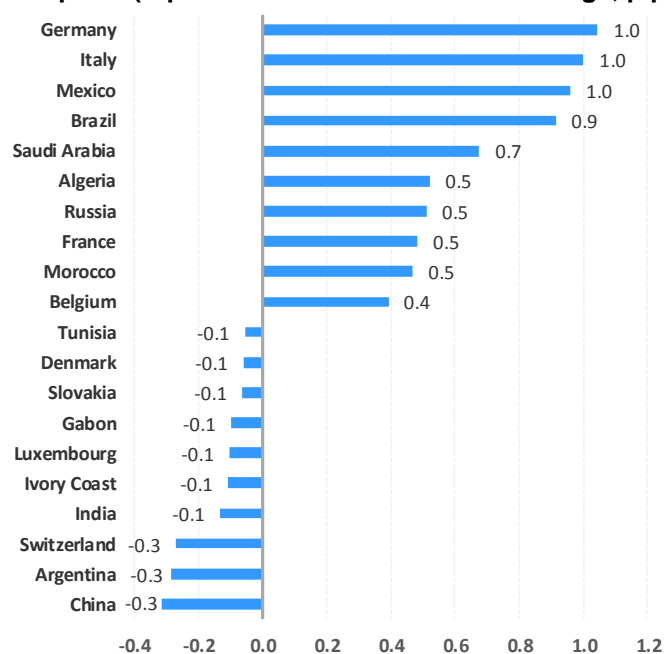
**Trade balance with the European Union** showed in February 2017 a surplus of 1,092.9 million euros (up from a surplus of 824.0 million in February 2016) and a surplus of 622.6 million euros with the euro area (593.0 million surplus in February 2016). **Trade deficit with the rest of the world** increased to 3,698.9 million euros (from a deficit of 2,585.0 million euros in February 2016).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in February 2017 (up by 8.3%) were Italy (1.6 percentage points), France (1.0 points), the United Kingdom (1.0 points) and Poland (0.6 points). Those destinations with the largest negative contributions were Saudi Arabia (-0.2 points), the United States (-0.2 points), Egypt (-0.2 points) and United Arab Emirates (-0.1 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in February 2017 (up by 11.4%) were Germany (1.0 percentage points), Italy (1.0 points), Mexico (1.0 points) and Brazil (0.9 points). The destinations with the largest negative contributions were China (-0.3 points), Argentina (-0.3 points), Switzerland (-0.3 points) and India (-0.1 points).

## **International data**

**In comparison to other geographical areas**, Spain's exports of goods increased by 8.3% year-on-year in February, a higher increase than that of the euro area (4.8%) and the European Union (4.4%). Within the European Union, exports also increased in Germany (3.1%), Italy (2.3%) and in the United Kingdom (11.3%), whereas those of France decreased (-0.2%). Outside the European Union, the United States exports increased by 4.8% and Japan's by 11.3%, while those of China decreased by 4.8%.



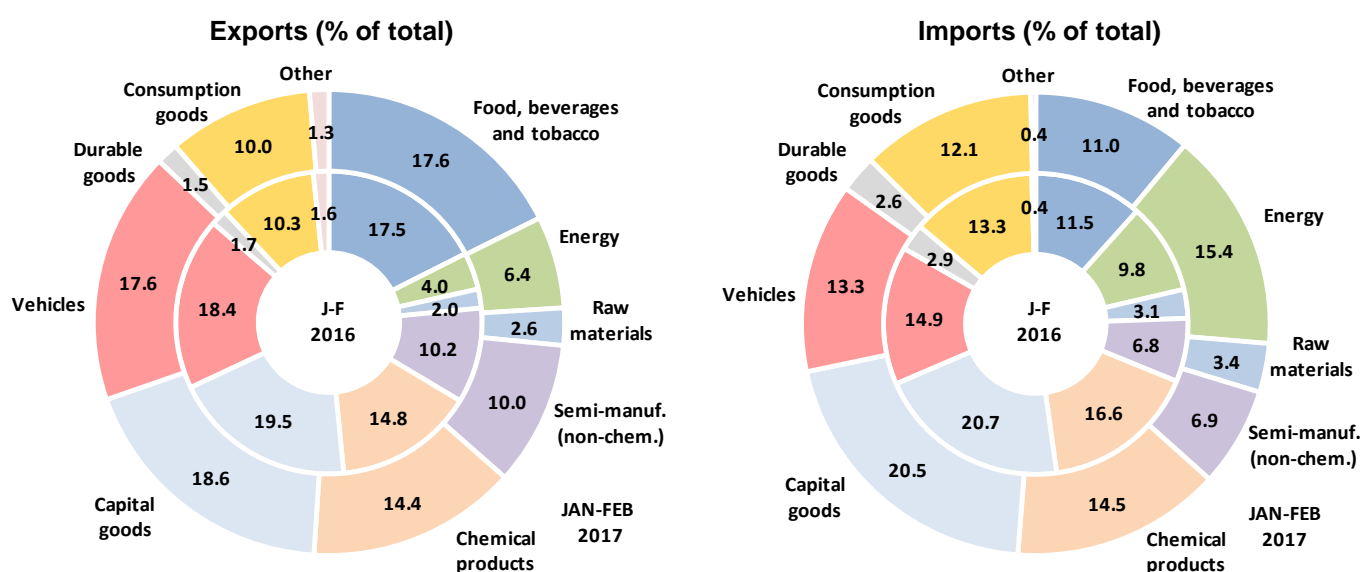
## JANUARY – FEBRUARY 2017

**Spain's exports advanced by 12.6%** in the period of January-February 2017 compared to the same period of 2016 to 43,515.7 million euros and imports augmented by 15.1% year-on-year to 49,256.4 million euros. In real terms, exports advanced by 12.2% year-on-year, as export prices increased by 0.3%, and imports rose by 8.6% year-on-year, as import prices advanced by 6.0%.

**Spain's trade deficit** increased to 5,740.7 million euros compared to the same period of 2016 (deficit of 4,147.6 million euros). The export/import **coverage ratio** reached 88.3%, 2.0 percentage points lower than in the same period of 2016 (90.3%, provisional data). The **non-energy trade balance** reached a deficit of 940.3 million euros, compared to a deficit of 1,501.5 million euros in January-February 2016, whereas the **energy trade deficit** increased by 81.4% year-on-year to 4,800.4 million euros.

### Sectoral data

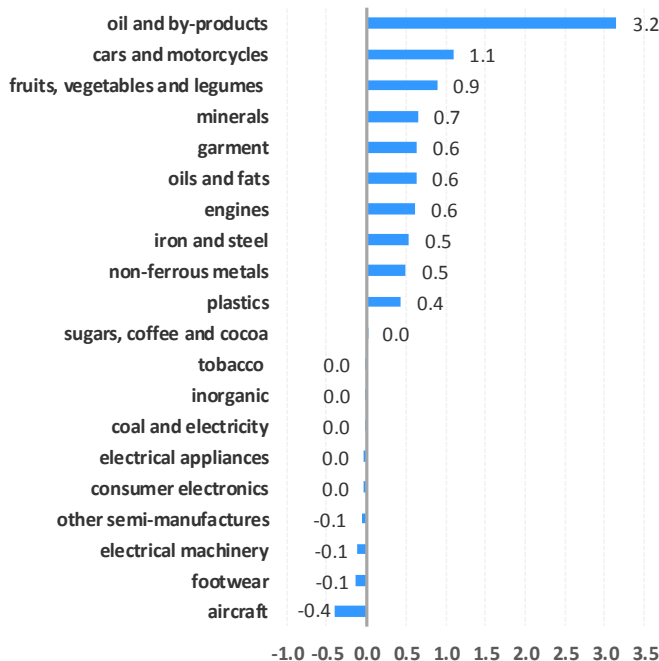
Spain's **main exporting sectors** in the period of January-February were *capital goods* (representing 18.6% of total exports, surging by 7.5% year-on-year), *food, beverages and tobacco* (17.6% of total, rising by 13.3%), *vehicles* (17.6% of total, increasing by 7.2%) and *chemical products* (14.4% of total, rising by 9.7%).



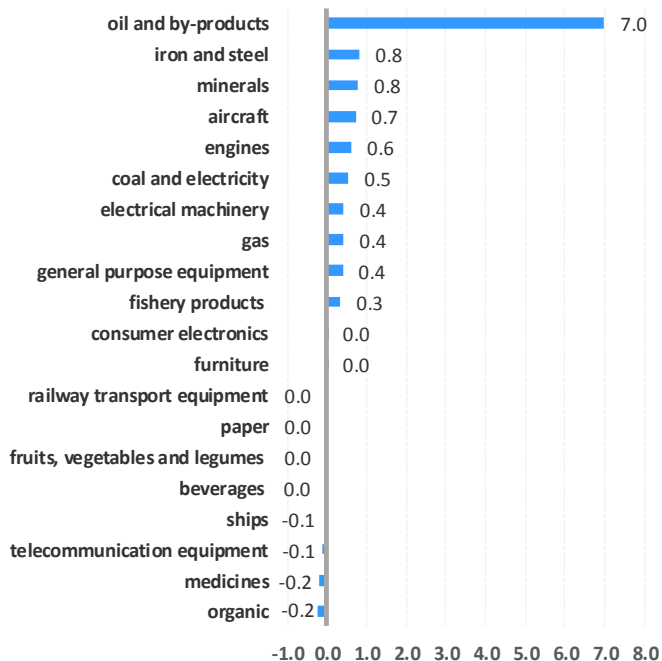
The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 20.5% of total and advancing by 13.9% year-on-year), *energy* (15.4% of total imports, surging by 81.5%), *chemical products* (14.5% of total imports, advancing by 0.7%) and *vehicles* (13.3% of total imports, surging by 2.7%).

Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 12.6%) were *oil and by-products* (3.2 percentage points), *cars and motorcycles* (1.1 points) and *fruits, vegetables and legumes* (0.9 points). On the other hand, the major negative contributions by subsectors corresponded to *aircraft* (-0.4 points), *footwear* (-0.1 points), and *electrical machinery* (-0.1 points).

**Exports (top/bottom contrib. to annual change, p.p.)**



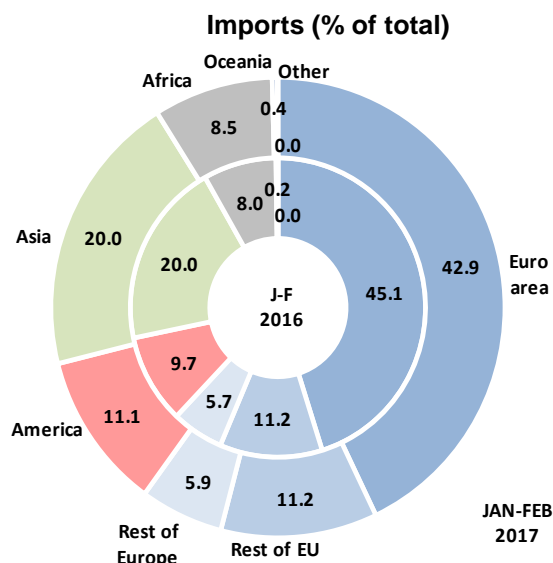
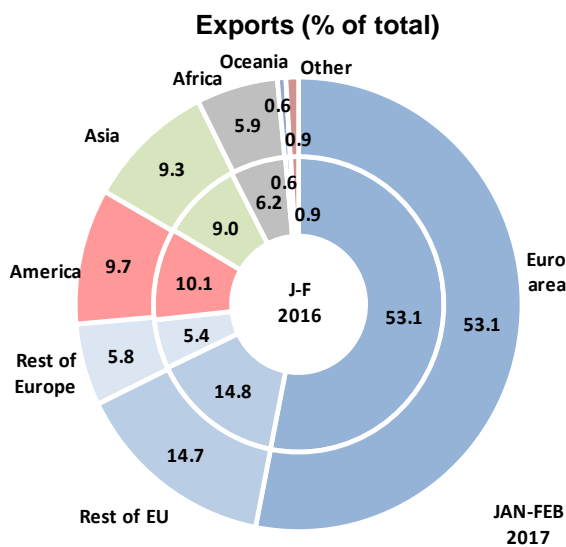
**Imports (top/bottom contrib. to annual change, p.p.)**



The **subsectors with most positive contributions** to the annual change in Spain's **imports** in January-February 2017 (up by 15.1%) were *oil and by-products* (7.0 points) and to a much lesser extent *iron and steel* (0.8 points) and *minerals* (0.8 points). The major negative contributions corresponded to *organic chemical products* (-0.2 points), *medicines* (-0.2 points) and *telecommunication equipment* (-0.1 points).

**Geographic data**

Exports to the **European Union** accounted for 67.8% of total exports in the period (down from 67.9% in the same period of 2016) and advanced by 12.3% year-on-year, while exports to the **euro area** accounted for 53.1% of total (53.1% in the same period of 2016) and augmented by 12.5%. Exports to the **rest of the world** accounted for 32.2% of total exports (32.1% in the same period of 2016) and increased by 13.2%.

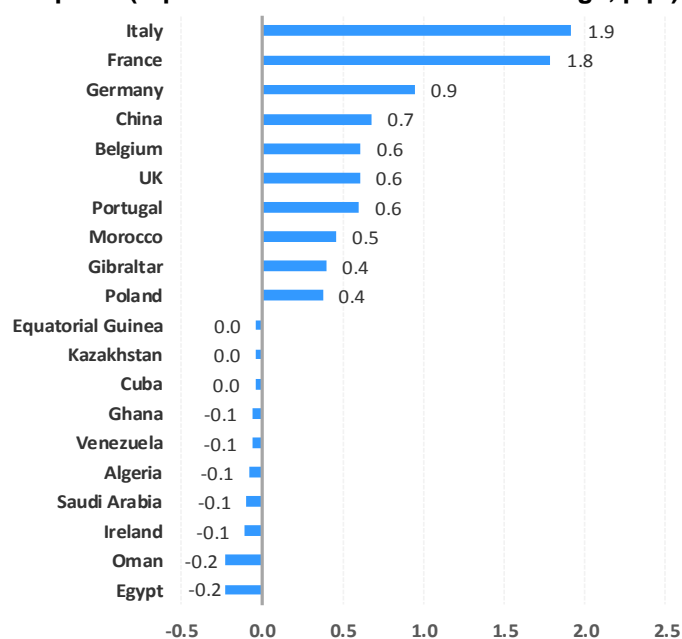


Imports from the **European Union** accounted for 54.1% of total imports in January-February 2017 (down from 56.4% in the same period of 2016) and expanded by 10.3% year-on-year. Imports from the **euro area** accounted for 42.9% (45.1% in the same period of 2016) and expanded by 9.3%. Imports from the **rest of the world** accounted for 45.9% of total imports (43.6% in the same period of 2016) and grew by 21.2%.

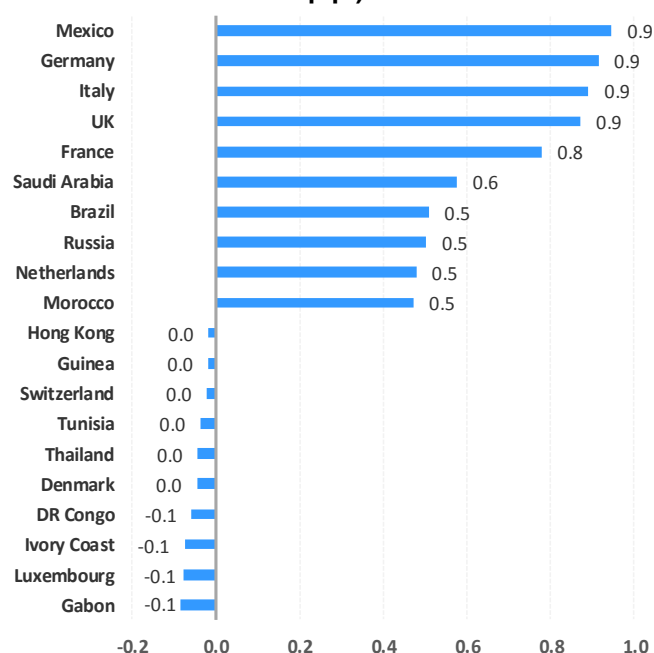
**Spain's trade surplus with the European Union and with the euro area** increased to 2,864.8 million euros and to 1,975.3 million euros respectively, up from surpluses of 2,127.0 million and 1,208.2 million euros in the same period of the previous year. The **trade deficit with the rest of the world** increased by 37.1% year-on-year to 8,605.5 million euros.

In terms of **contribution to the annual change of exports** (up by 12.6%), the main contributions were those of Italy (1.9 percentage points), France (1.8 points), Germany (0.9 points) and China (0.7 points). Those destinations with the largest negative contributions were Egypt (-0.2 points), Oman (-0.2 points), Ireland (-0.1 points) and Saudi Arabia (-0.1 points).

**Imports (top/bottom contrib. to annual change, p.p.)**



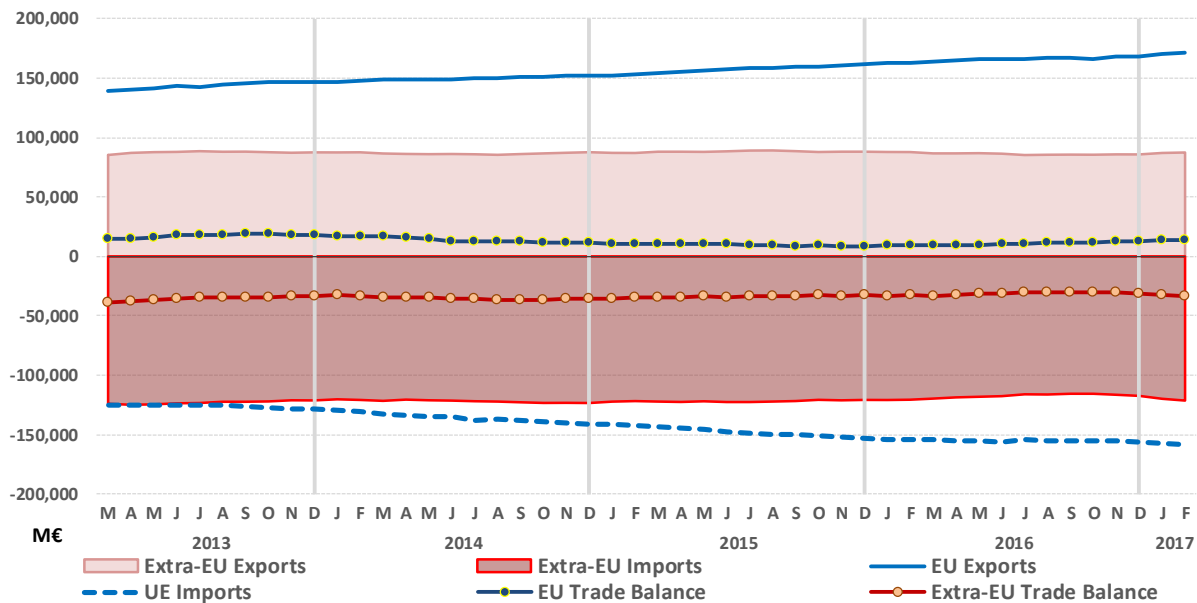
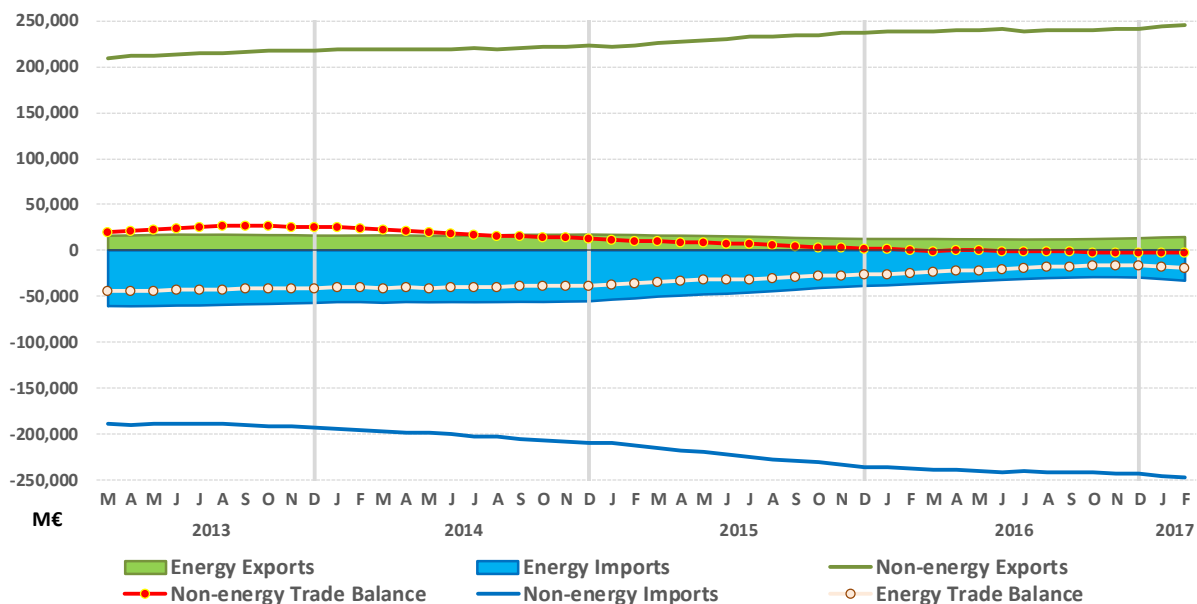
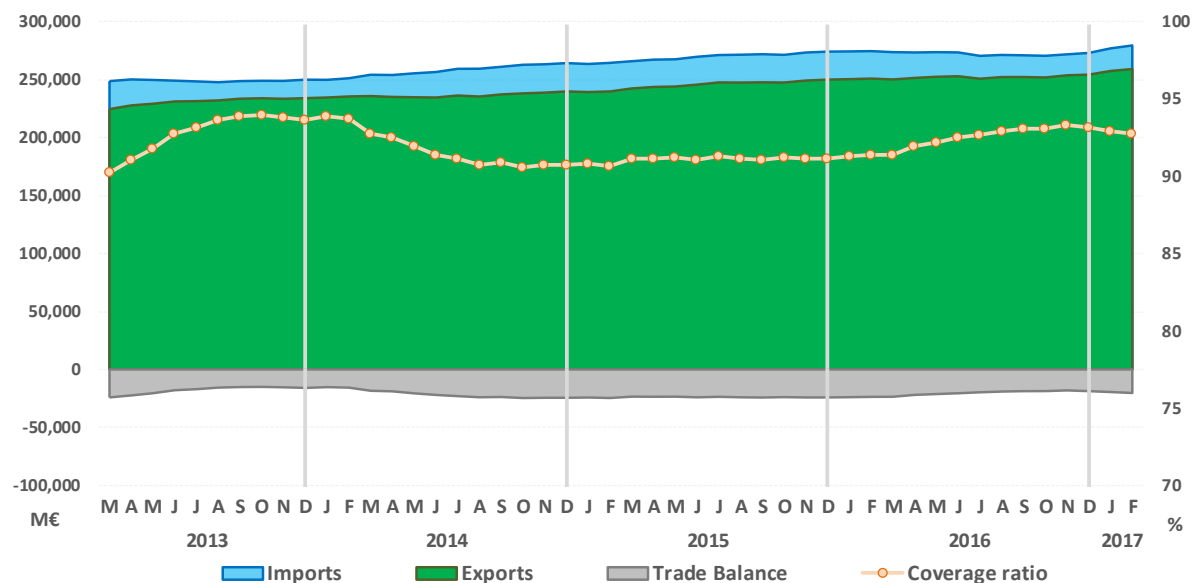
Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's imports in the period (up by 15.1%) were Mexico (0.9 percentage points), Germany (0.9 points), Italy (0.9 points), and the United Kingdom (0.9 points). The destinations with the largest negative contributions were Gabon (-0.1 points), Luxembourg (-0.1 points), Ivory Coast (-0.1 points), and DR Congo (-0.1 points).

In the period January-February, the number of **Spanish exporters** expanded by 1.2% year-on-year to 62,655 exporters, out of which 21,734 had already exported at least 50,000 euros worth of goods in the period, 3.4% more than in the same period of 2016. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 38,581 in the period, 61.6% of total exporters and 1.7% more than in the same period of 2016. Their exports reached 41,619.4 million, 95.6% of total exports and 12.7% more than in the same period of the previous year.

## **International data**

**In comparison to other geographical areas**, Spain's exports of goods advanced by 12.6% year-on-year in the period of January-February 2017, a higher rate than those attained by the euro area (8.0%) and the European Union (7.9%). Within the European Union, exports also increased in Germany (7.1%), France (1.1%), Italy (7.2%) and the United Kingdom (19.2%). Outside the European Union, the United States exports increased by 6.9% and Japan's by 6.5%, whereas those of China decreased by 0.2%
