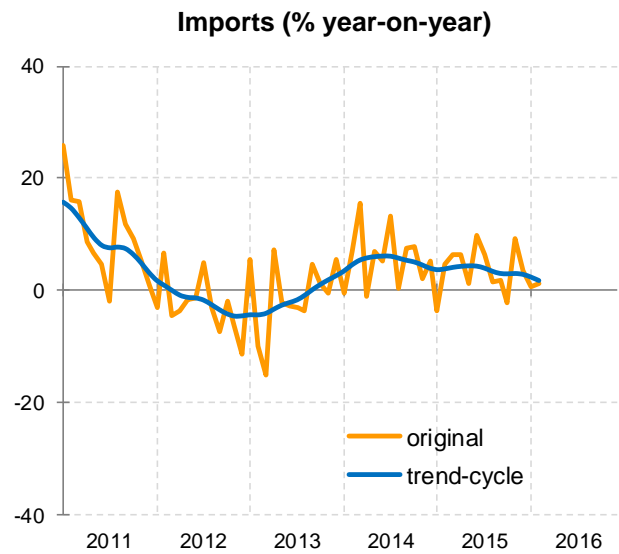
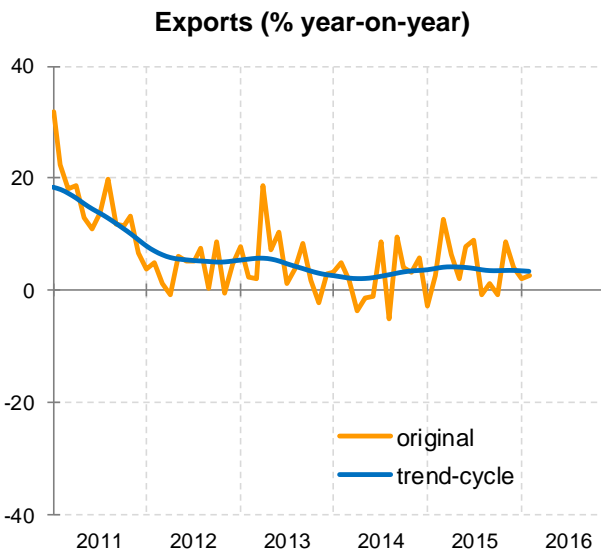

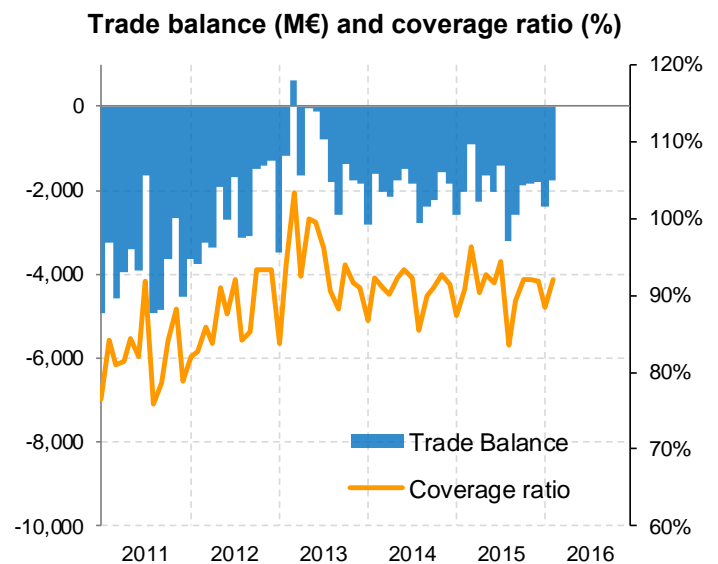


## FEBRUARY 2016

In February 2016, **Spain's exports grew by 2.7%** year-on-year in nominal terms to 20,390.7 million euros, whereas **imports grew by 1.2%** to 22,151.7 million euros. With seasonally adjusted data, exports grew by 1.3% year-on-year, while imports diminished by 0.4%. In **real terms**, exports advanced by 4.9% year-on-year, as export prices decreased by 2.1%, and imports rose by 4.6%, as import prices fell by 3.3%. In nominal terms on a **month-on-month** basis, exports grew by 11.6%, and imports by 7.3%, whereas with seasonally adjusted data, exports shrank by 1.1% month-on-month and imports declined by 0.2%.

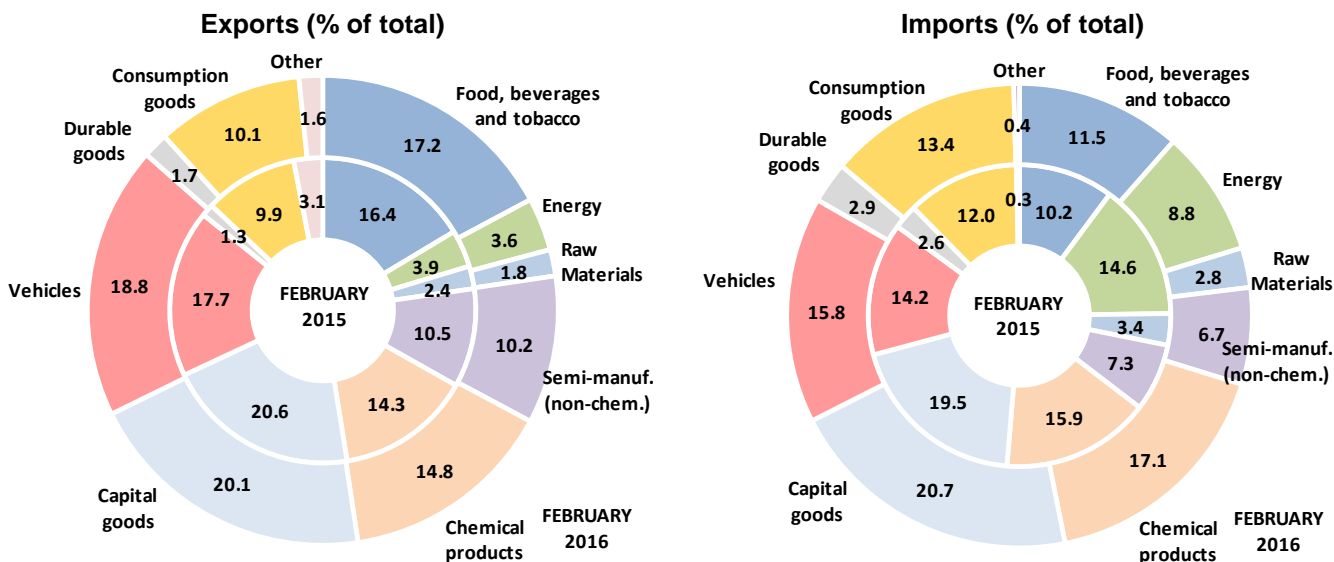


Spain's **trade balance** registered a deficit of 1,761.0 million euros, down from a deficit of 2,037.2 million euros in February 2015 (provisional data). The export/import **coverage ratio** reached 92.1%, 1.4 points higher than in the same month of 2015 (90.7% in February 2015 with provisional data). The **non-energy trade balance** reached a deficit of 559.2 million euros, in contrast to a surplus of 380.9 million in the same month of 2015. The **energy trade deficit** fell by 50.3% year-on-year to 1,201.9 million euros (against a deficit of 2,418.1 million euros in February 2015).



### Sectoral data

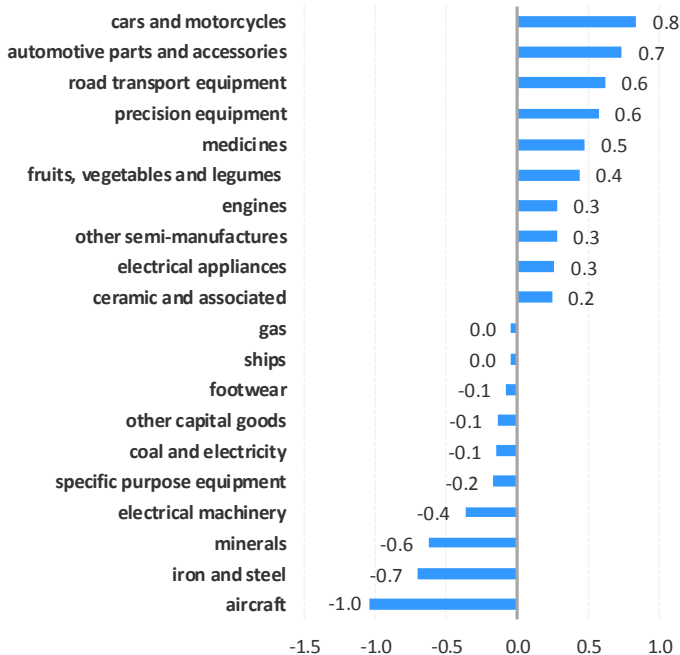
Spain's **main exporting sectors** in February 2016 were *capital goods* (whose exports represented 20.1% of total exports and they went up by 0.4% year-on-year), *vehicles* (18.8% of total, surging by 8.9%), *food, beverages and tobacco* (17.2% of total, growing by 7.7%) and *chemical products* (14.8% of total, rising by 6.2%).



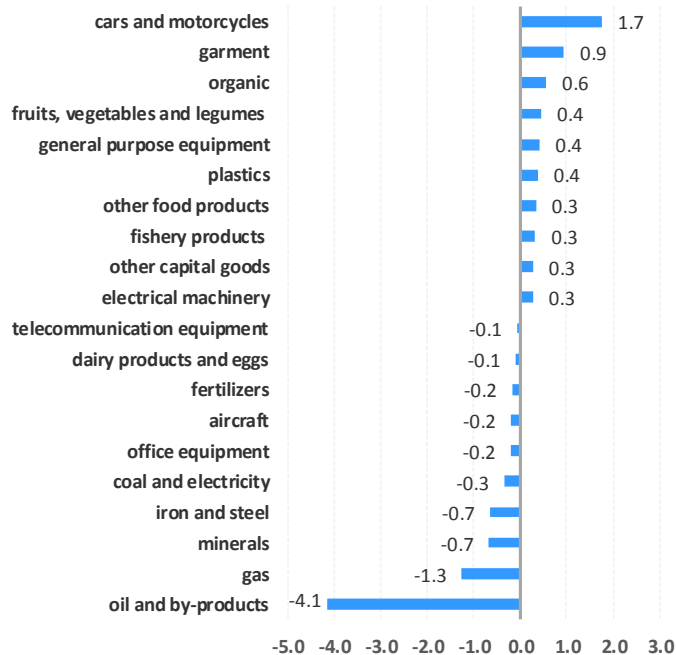
The most significant sectors of Spain's imports were *capital goods* (whose imports represented 20.7% of total and they increased by 7.3% year-on-year), *chemical products* (17.1% of total imports, advancing by 8.5%), *vehicles* (15.8% of total imports, surging by 12.2%), and *consumption goods* (13.4% of total imports, rising by 13.4%).

Among subsectors, the largest contributions to the annual change in Spain's exports in February 2016 (up by 2.7%) came from *cars and motorcycles* (0.8 points), *automotive parts and accessories* (0.7 points) and *road transport equipment* (0.6 points). The major negative contributions corresponded to *aircraft* (-1.0 points), *iron and steel* (-0.7 points) and *minerals* (-0.6 points).

Exports (top/bottom contrib. to annual change, p.p.)



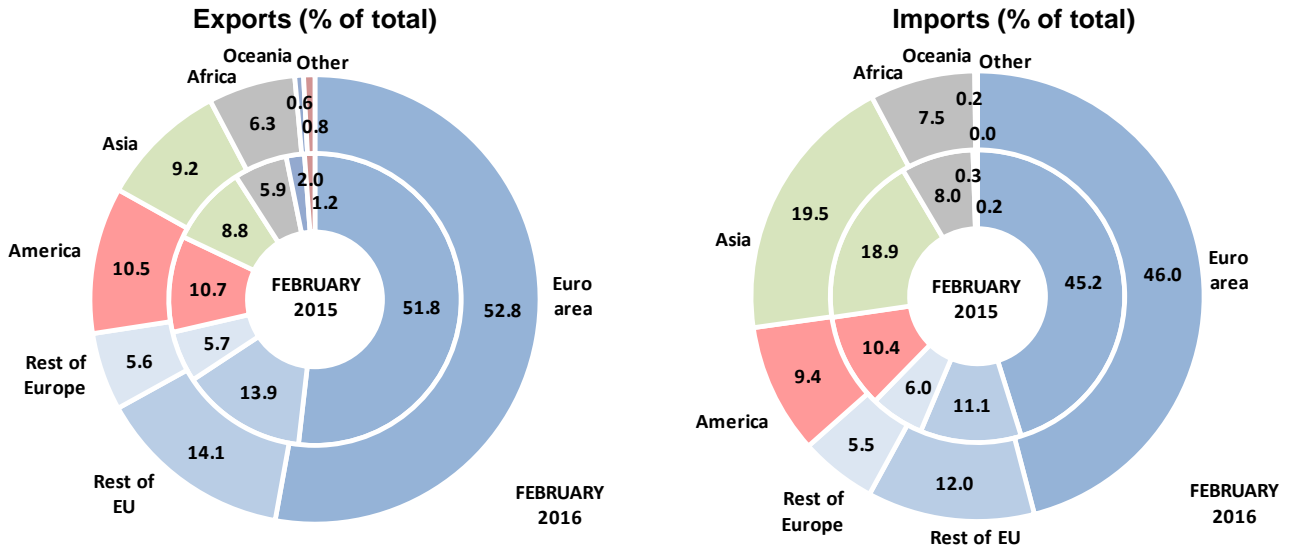
Imports (top/bottom contrib. to annual change, p.p.)



The subsectors with the most positive contribution to the annual change in Spain's imports in February 2016 (1.2% growth) were *cars and motorcycles* (1.7 points), *garment* (0.9 points) and *organic chemical products* (0.6 points). The major negative contributions corresponded to *oil and by-products* (-4.1 points), *gas* (-1.3 points) and *minerals* (-0.7 points).

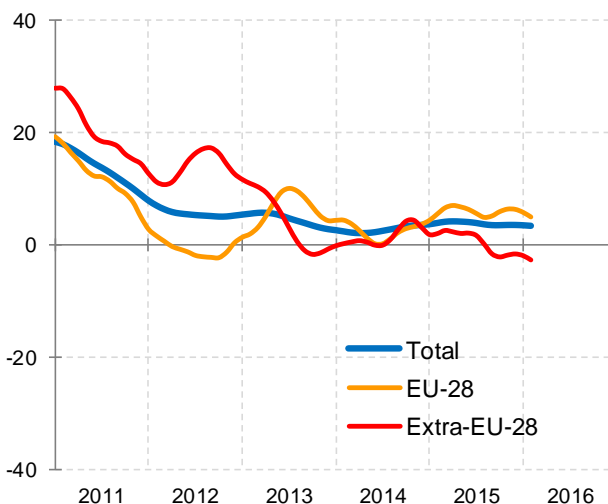
## Geographic data

Exports to the **European Union** accounted for 67.0% of total exports in February 2016 (up from 65.7% in February 2015) and grew by 4.6% year-on-year. Exports to the **euro area** accounted for 52.8% (up from 51.8% in February 2015) and advanced by 4.7%. Exports to **non-EU countries** accounted for 33.0% of total exports (down from 34.3% in February 2015) as they declined by 1.0% year-on-year.

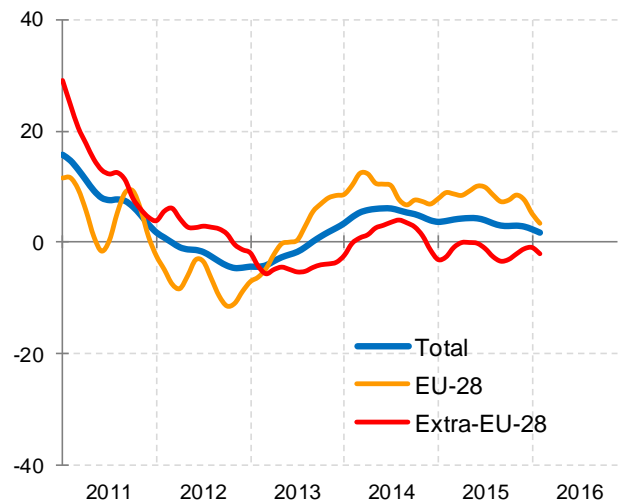


Imports from the **European Union** accounted for 57.9% of total imports in February 2016 (up from 56.3% in February 2015) and grew by 4.0% year-on-year. Imports from the **euro area** represented 46.0% (up from 45.2% in February 2015) and went up by 2.8%. Imports from **non-EU countries** accounted for 42.1% of total imports in February 2016 (down from 43.7% in February 2015) as they declined by 2.5% year-on-year.

Exports EU and extra-EU (% y-o-y trend-cycle)



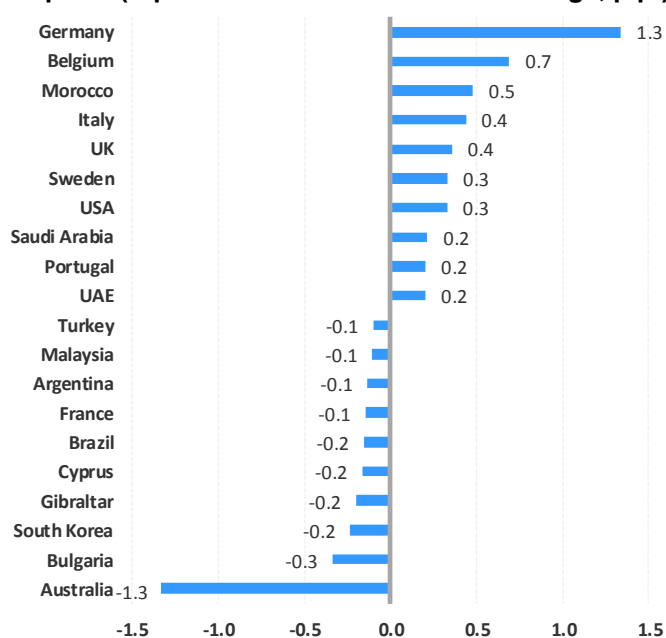
Imports EU and extra-EU (% y-o-y trend-cycle)



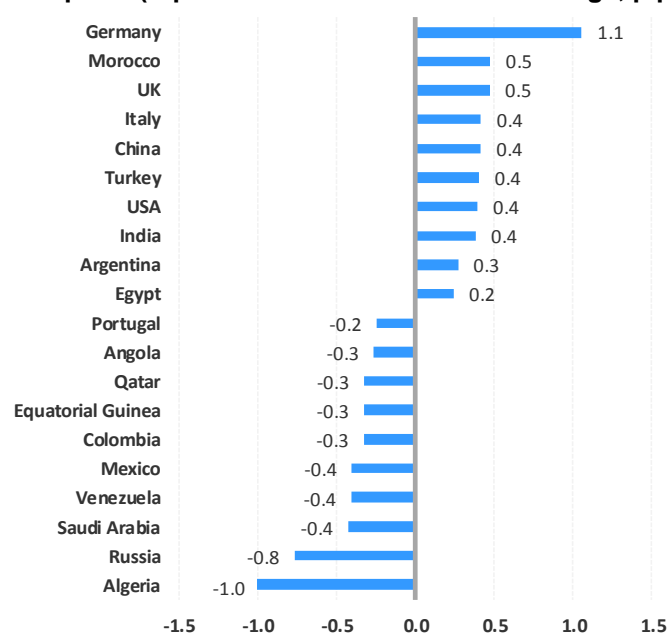
**Trade balance with the European Union** showed in February 2016 a surplus of 824.0 million euros (up from a surplus of 721.4 million in February 2015) and a surplus of 593.0 million euros with the euro area (390.4 million surplus in February 2015). **Trade deficit with the rest of the world** decreased to 2,585.0 million euros (from a deficit of 2,758.7 million euros in February 2015).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in February 2016 (up by 2.7%) were Germany (1.3 percentage points), Belgium (0.7 points), Morocco (0.5 points) and Italy (0.4 points). Those destinations with the largest negative contributions were Australia (-1.3 points), Bulgaria (-0.3 points), South Korea (-0.2 points) and Gibraltar (-0.2 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in February 2016 (up by 1.2%) were Germany (1.1 percentage points), Morocco (0.5 points), the United Kingdom (0.5 points) and Italy (0.4 points). The destinations with the largest negative contributions were Algeria (-1.0 points), Russia (-0.8 points), Saudi Arabia (-0.4 points) and Venezuela (-0.4 points).

### International data

**In comparison to other geographical areas**, Spain's exports of goods grew by 2.7% year-on-year in February, a higher increase than that of the euro area (2.1%), and the European Union (2.3%). Within the European Union, exports also increased in Germany (4.1%), Italy (3.3%) and the United Kingdom (5.4%), while fell in France (-0.2%). Outside the European Union, the United States' exports decreased by 3.9%, China's by 25.4% and Japan's by 4.0%.



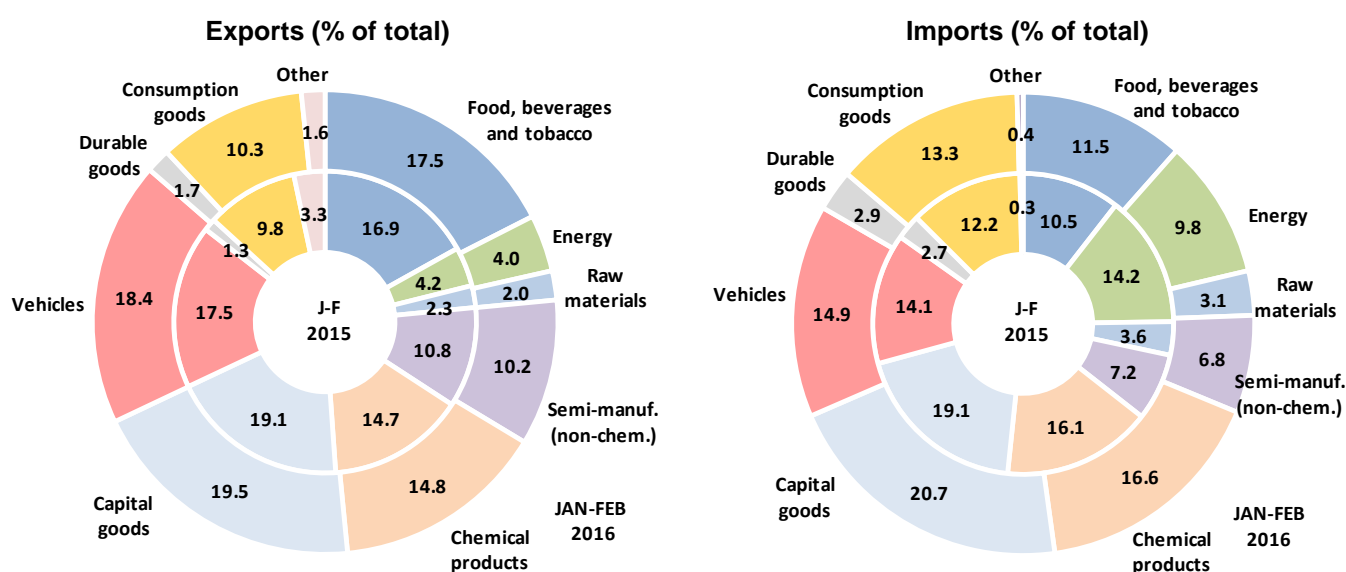
## JANUARY – FEBRUARY 2016

**Spain's exports grew by 2.4%** in the period of January-February 2016 compared to the same period of 2015 to 38,658.0 million euros, whereas Imports went up by 1.0% year-on-year to 42,805.6 million euros. In real terms, exports expanded by 4.1% year-on-year, as export prices shrank by 1.6%, and imports rose by 3.9% year-on-year, as import prices decreased by 2.8%.

**Spain's trade deficit** decreased to 4,147.6 million euros compared to the same period of 2015 (deficit of 4,633.4 million euros). The export/import **coverage ratio** reached 90.3%, 1.2 percentage points higher than in the same period of 2015 (89.1% with provisional data). The **non-energy trade balance** reached a deficit of 1,501.5 million euros, compared to a deficit of 198.3 million euros in January-February 2015, whereas the **energy trade deficit** declined by 40.3% year-on-year to 2,646.1 million euros.

### Sectoral data

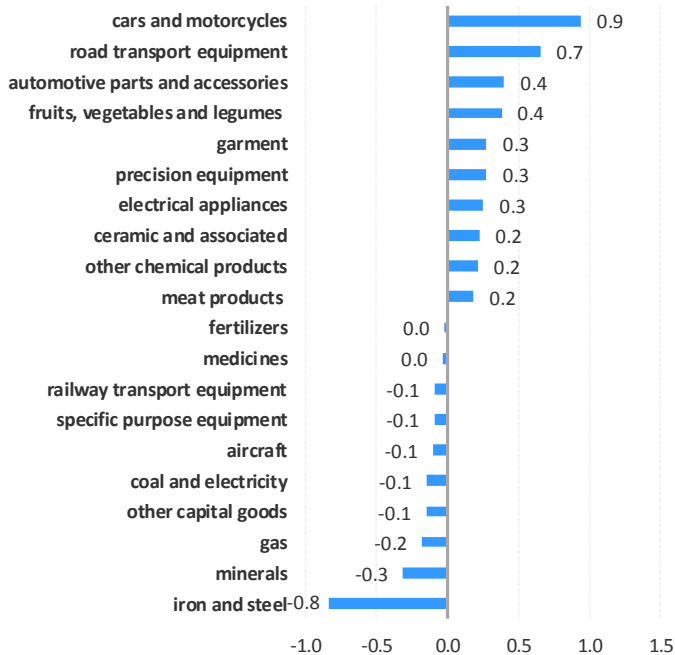
Spain's **main exporting sectors** in the period of January-February were *capital goods* (whose exports represented 19.5% of total exports and they increased by 4.5% year-on-year), *vehicles* (18.4% of total, rising by 7.6%), *food, beverages and tobacco* (17.5% of total, advancing by 6.0%) and *chemical products* (14.8% of total, expanding by 3.3%).



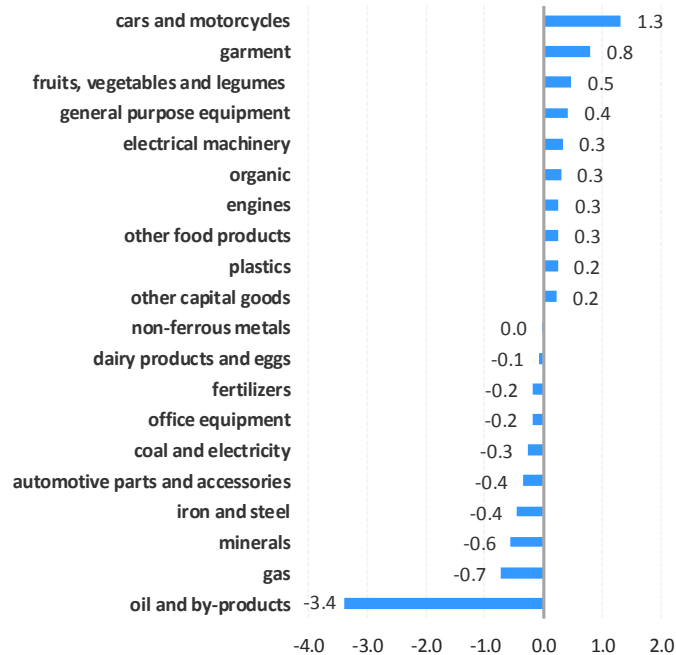
The **largest shares by sector of Spain's imports** were *capital goods* (whose imports represented 20.7% of total imports and they increased by 9.4% year-on-year), *chemical products* (16.6% of total imports, rising by 4.1%), *vehicles* (14.9% of total imports, surging by 6.9%) and *consumption goods* (13.3% of total imports, growing by 10.6%).

Among **subsectors**, the largest contributions to the annual change to Spain's **exports** (up by 2.4%) were *cars and motorcycles* (0.9 percentage points), *road transport equipment* (0.7 points) and *automotive parts and accessories* (0.4 points). On the other hand, the major negative contributions by subsectors corresponded to *iron and steel* (-0.8 points), *minerals* (-0.3 points), and *gas* (-0.2 points).

**Exports (top/bottom contrib. to annual change, p.p.)**



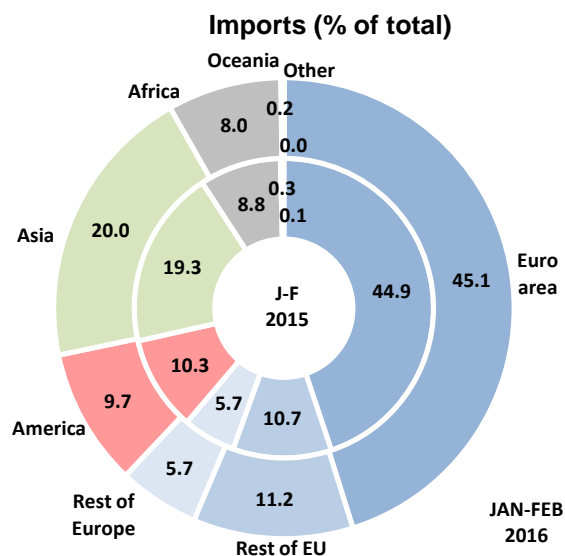
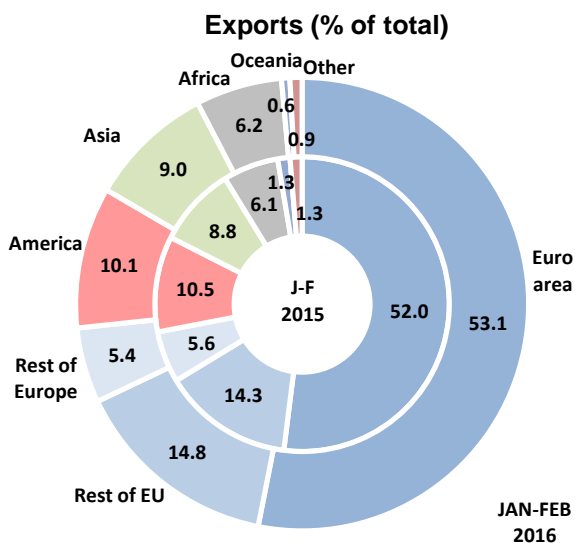
**Imports (top/bottom contrib. to annual change, p.p.)**



The **subsectors with the most positive contribution** to the annual change in Spain's **imports** in January-February 2016 (up by 1.0%) were *cars and motorcycles* (1.3 points), *garment* (0.8 points) and *fruits, vegetables and legumes* (0.5 points). The major negative contributions corresponded to *oil and by-products* (-3.4 points), *gas* (-0.7 points) and *minerals* (-0.6 points).

**Geographic data**

Exports to the **European Union** accounted for 67.9% of total exports in the period (up from 66.3% in the same period of 2015) and increased by 4.9 year-on-year, while exports to the **euro area** accounted for 53.1% of total (52.0% in the same period of 2015) and went up by 4.6%. Exports to the **rest of the world** accounted for 32.1% of total exports (33.7% in the same period of 2015) and fell by 2.5% year-on-year.



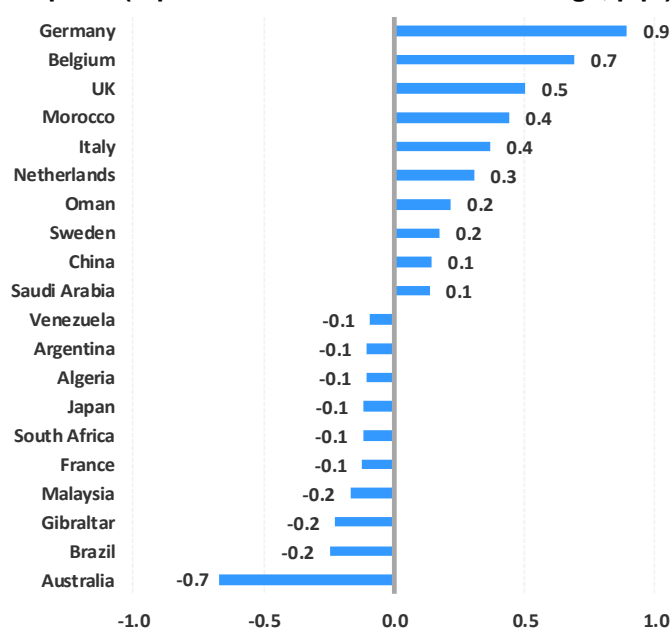
Imports from the **European Union** accounted for 56.4% of total imports in January-February 2016 (up from 55.5% in the same period of 2015) and increased by 2.6% year-on-year. Imports from the **euro area** accounted for 45.1% (44.9% in the same period of 2015) and went up by 1.6%. Imports from the **rest of**

the world accounted for 43.6% of total exports (44.5% in the same period of 2015) and fell by 1.0% year-on-year.

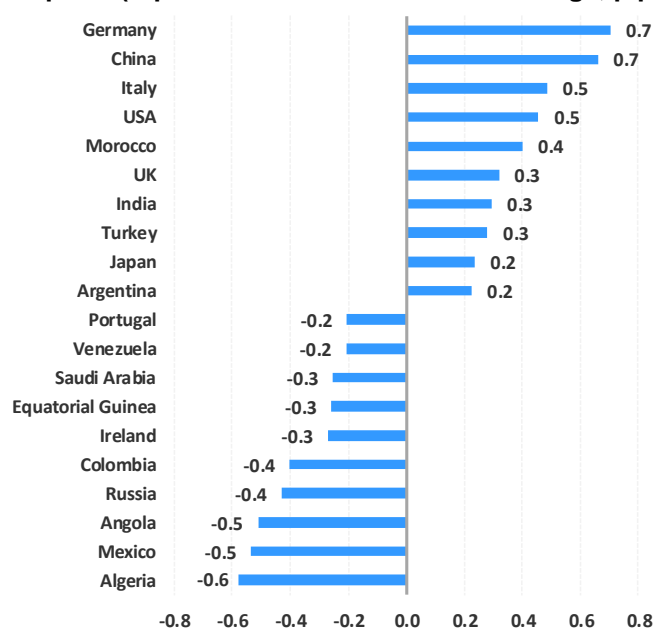
Spain's trade surplus with the European Union and with the euro area increased to 2.127.0 million euros and to 1.208.2 million euros respectively, up from surpluses of 1,504.9 million and 613.2 million euros in the same period of the previous year. The trade deficit with the rest of the world increased by 2.2% year-on-year to 6,274.6 million euros.

In terms of contribution to the annual change of exports (up by 2.4%), the main destinations for Spain's exports were Germany (0.9 percentage points), Belgium (0.7 points), the United Kingdom (0.5 points) and Morocco (0.4 points). Those destinations with the largest negative contributions were Australia (-0.7 points), Brazil (-0.2 points), Gibraltar (-0.2 points) and Malaysia (-0.2 points).

Imports (top/bottom contrib. to annual change, p.p.)



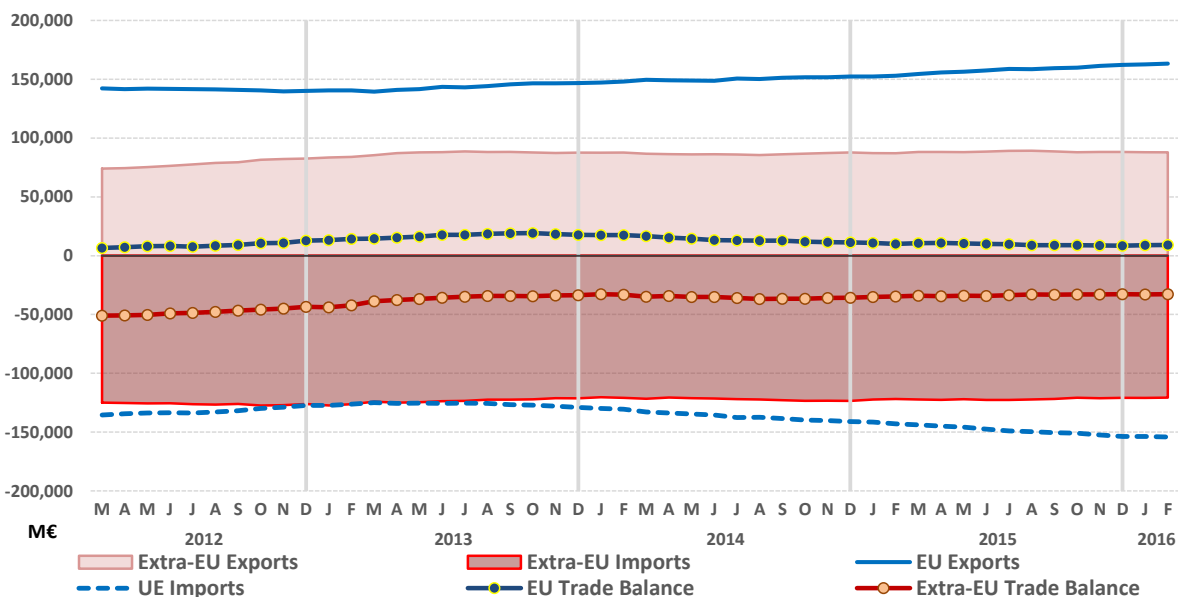
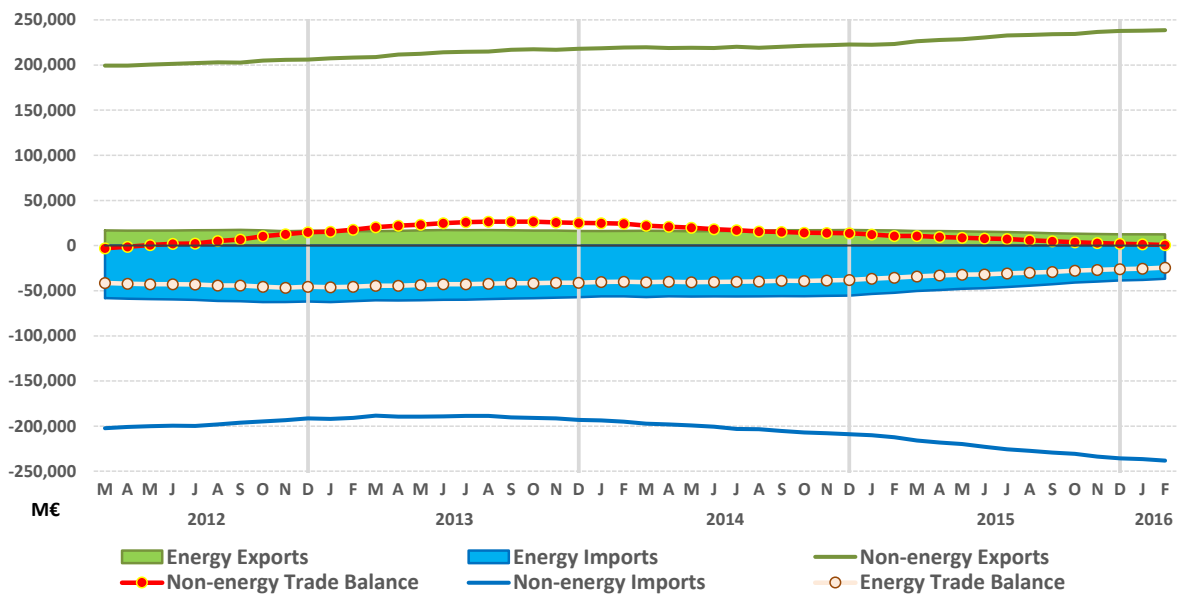
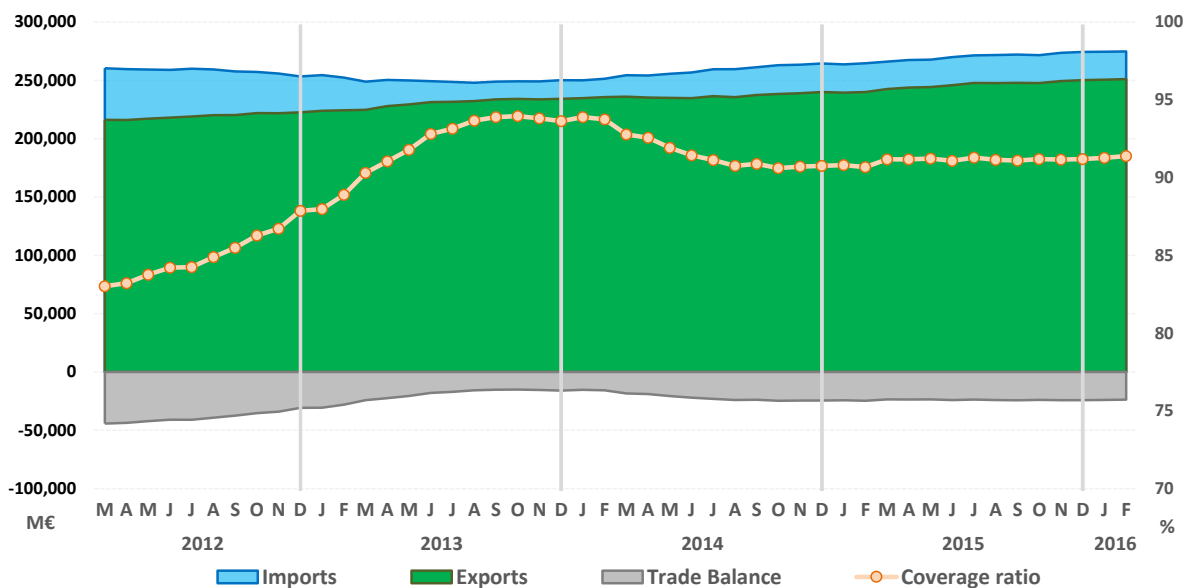
Regarding imports, the countries with the largest contribution to the annual change in Spain's imports in the period (up by 1.0%) were Germany (0.7 percentage points), China (0.7 points), Italy (0.5 points) and the United States (0.5 points). The destinations with the largest negative contributions were Algeria (-0.6 points), Mexico (-0.5 points), Angola (-0.5 points) and Russia (-0.4 points).

In the period, the number of Spanish exporters increased by 3.0% year-on-year to 61,930 exporters, out of which 21,012 had already exported at least 50,000 euros worth of goods in the period, 2.3% more than in the same period of 2015. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 37,951, 61.3% of total exporters and 4.5% more than in the same period of 2015. Their exports reached 36,929.3 million, 95.5% of total exports and 3.4% more than in the same period of the previous year.

## International data

In comparison to other geographical areas, Spain's exports of goods grew by 2.4% year-on-year in the period of January-February 2016, a higher rate than those attained by the euro area (0.5%) and the European Union (0.7%). Within the European Union, exports also increased in Germany (1.4%) and Italy (0.1%), while fell in France (-0.8%) and in the United Kingdom (-0.1%). Outside the European Union, the United States' exports decreased by 7.4% China's by 17.9% and Japan's by 8.5%.
