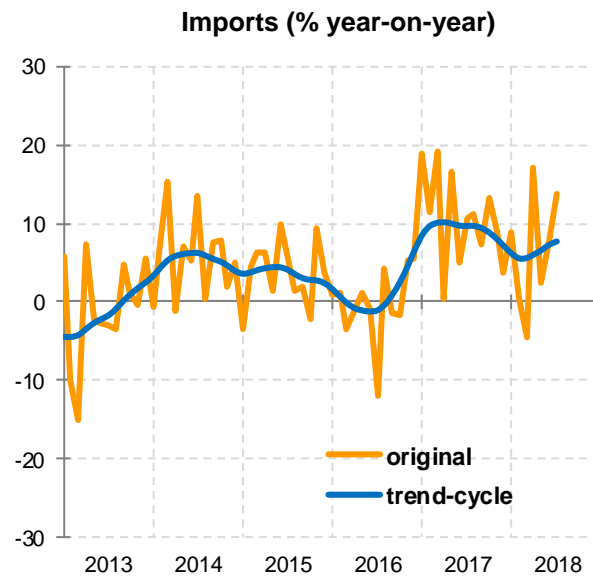
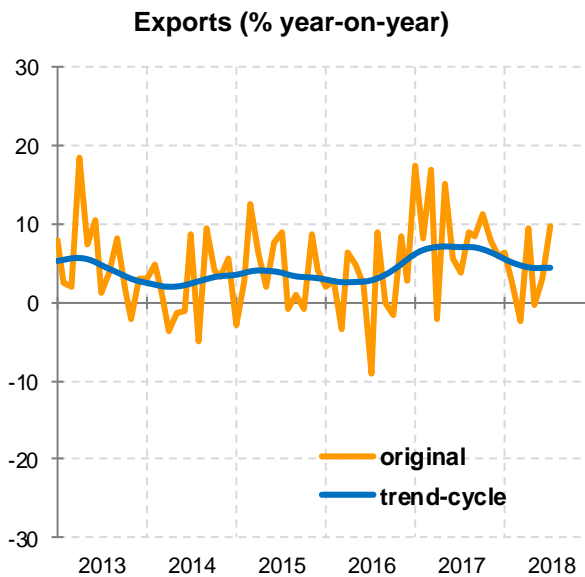

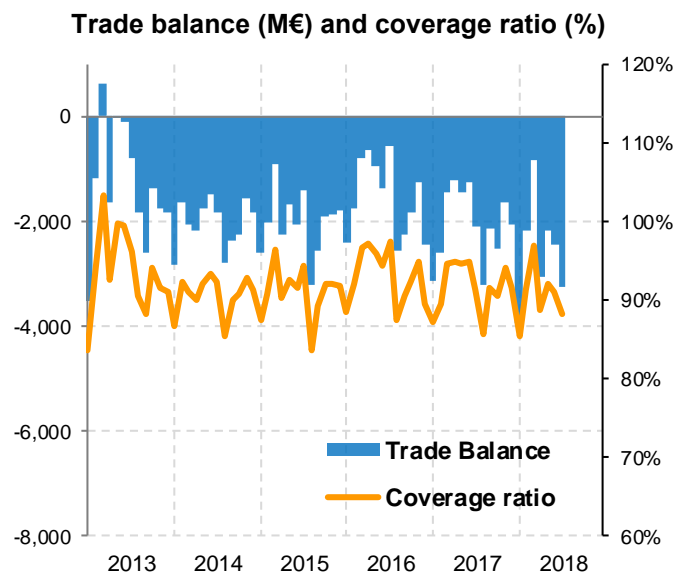


## JULY 2018

In July 2018, **Spain's exports increased by 9.8%** year-on-year in nominal terms to 24,354.9 million euros, and **imports rose by 13.6%** to 27,602.5 million euros. With seasonally adjusted data, exports grew by 6.8% year-on-year, and imports by 10.3%. In **real terms**, exports expanded by 6.3% year-on-year, as export prices advanced by 3.3%, and imports rose by 4.9%, as import prices increased by 8.3%. In nominal terms on a **month-on-month** basis, exports fell by 1.5%, whereas imports expanded by 1.6%. With seasonally adjusted data, exports decreased by 0.1% month-on-month, while imports advanced by 2.2%.

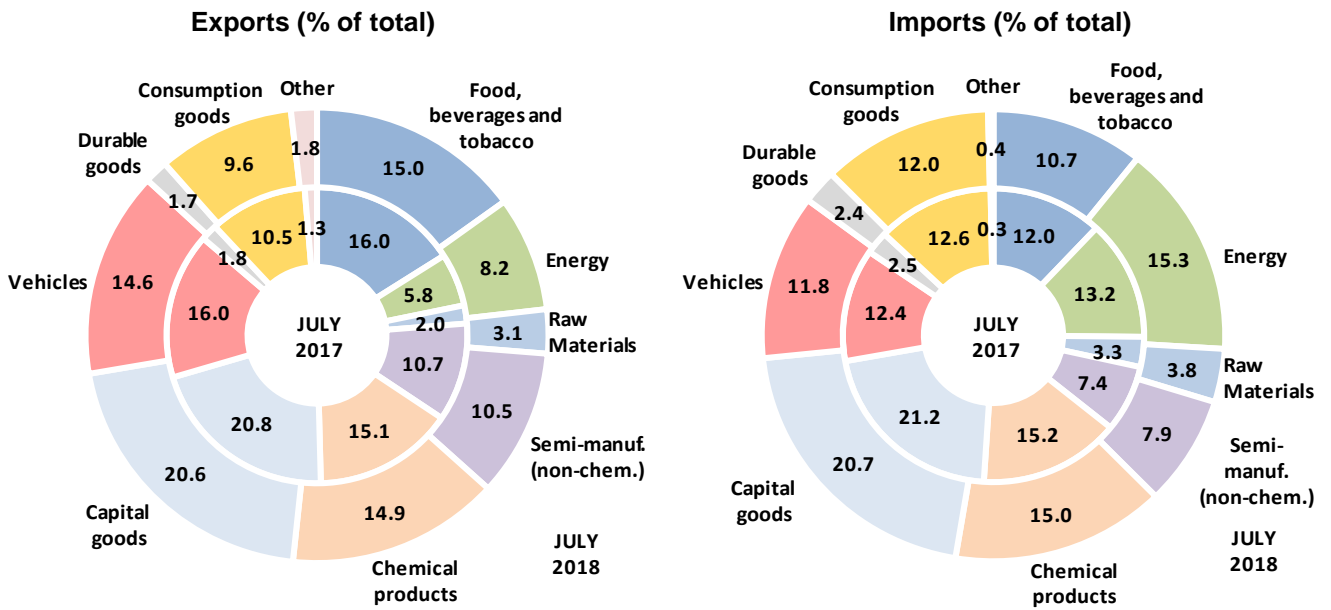


Spain's **trade balance** registered a deficit of 3,247.7 million euros, up from a deficit of 2,098.7 million euros in July 2017 (provisional data). The export/import **coverage ratio** reached 88.2%, 3.1 percentage points lower than in the same month of 2017 (91.4% in July 2017 with provisional data). The **non-energy trade balance** reached a deficit of 1,013.7 million euros, from a deficit of 174.6 million in the same month of 2017. The **energy trade deficit** rose by 16.1% year-on-year to 2,234.0 million euros (compared to a deficit of 1,924.1 million euros in July 2017).



### Sectoral data

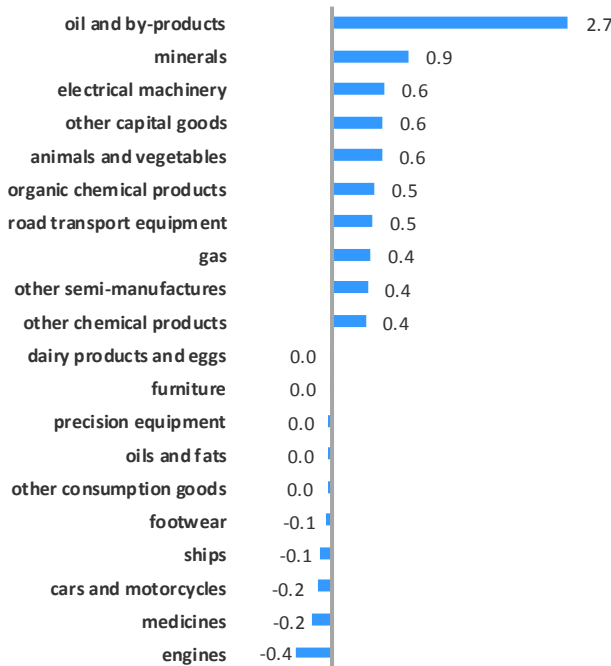
Spain's **main exporting sectors** in July 2018 were *capital goods* (representing 20.6% of total exports and growing by 8.8% year-on-year), *food, beverages and tobacco* (15.0% of total, expanding by 3.2%), *chemical products* (14.9% of total, rising by 8.1%) and *vehicles* (14.6% of total, advancing by 0.7%).



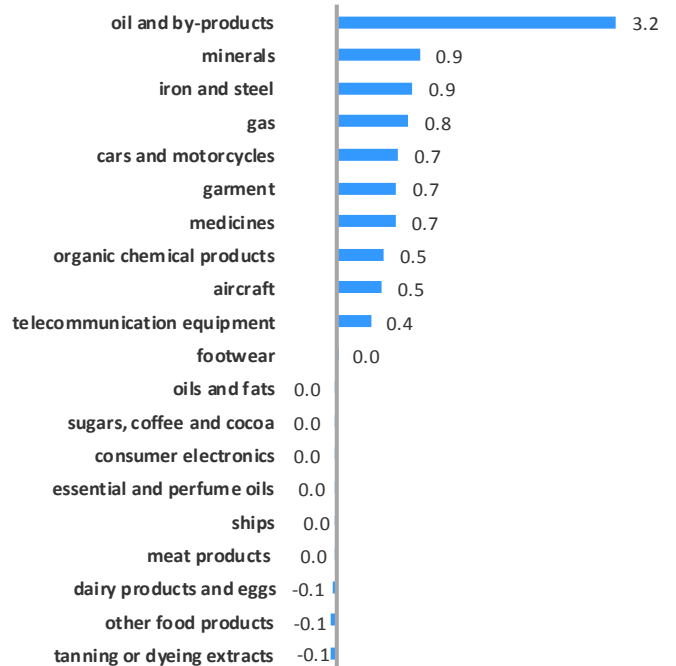
The most significant sectors of Spain's imports were *capital goods* (representing 20.7% of total imports and increasing by 11.5% year-on-year), *energy* (15.3% of total, surging by 31.6%), *chemical products* (15.0% of total, growing by 12.1%) and *consumption goods* (12.0% of total, expanding by 8.0%).

Among subsectors, the largest contributions to the annual change in Spain's exports in July 2018 (up by 9.8%) came from *oil and by-products* (2.7 points), *minerals* (0.9 points) and *electrical machinery* (0.6 points). The major negative contributions corresponded to *engines* (-0.4 points), *medicines* (-0.2 points) and *cars and motorcycles* (-0.2 points).

Exports (top/bottom contrib. to annual change, p.p.)



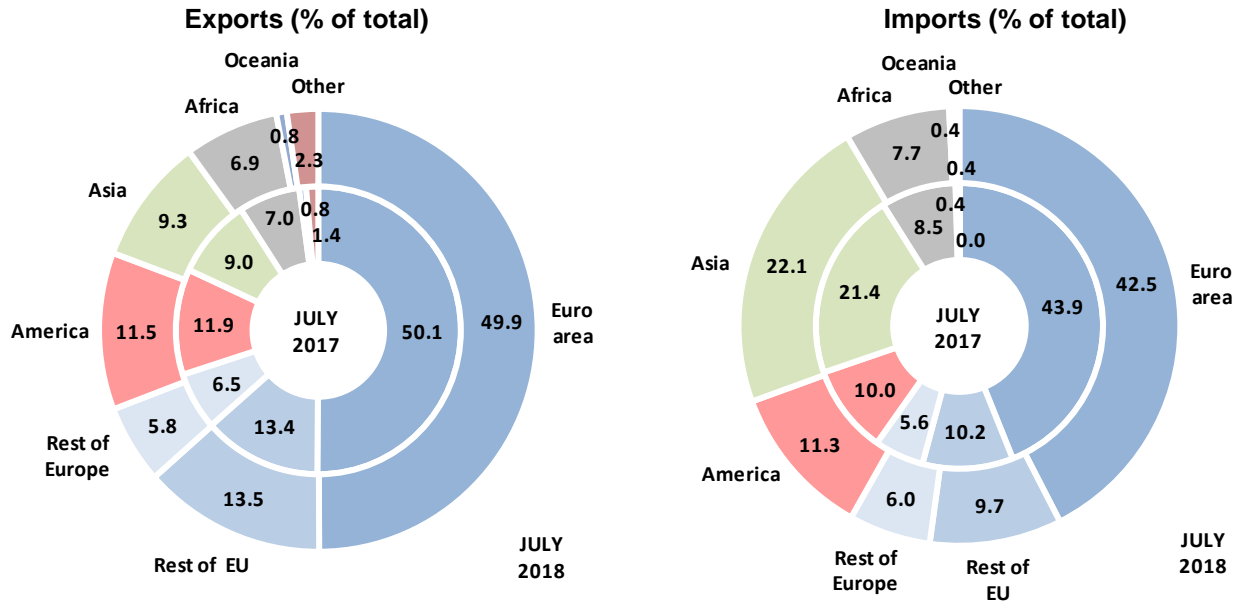
Imports (top/bottom contrib. to annual change, p.p.)



The subsectors with the most positive contribution to the annual change in Spain's imports in July 2018 (up by 13.6%) were *oil and by-products* (3.2 points), *minerals* (0.9 points) and *iron and steel* (0.9 points). The major negative contributions corresponded to *tanning or dyeing extracts* (-0.1 points), *other food products* (-0.1 points) and *dairy products and eggs* (-0.1 points).

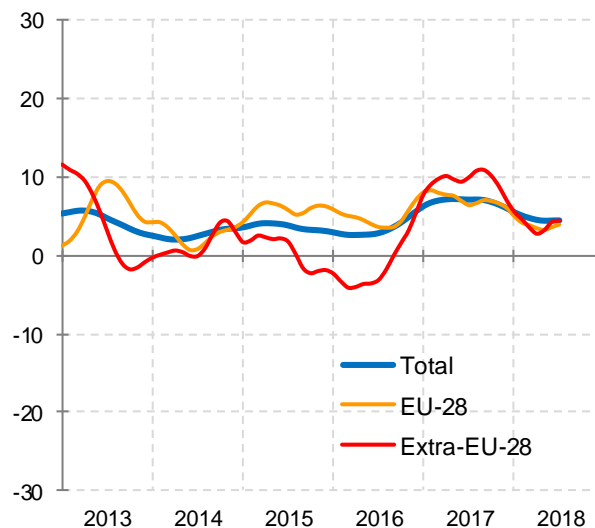
## Geographic data

Exports to the **European Union** accounted for 63.4% of total exports in July 2018 (down from 63.5% in July 2017) and grew by 9.6% year-on-year. Exports to the **euro area** ran at 49.9% (down from 50.1% in July 2017) and advanced by 9.4%. Exports to **non-EU countries** represented 36.6% of total exports (up from 36.5% in July 2017) as they augmented by 10.0% year-on-year.

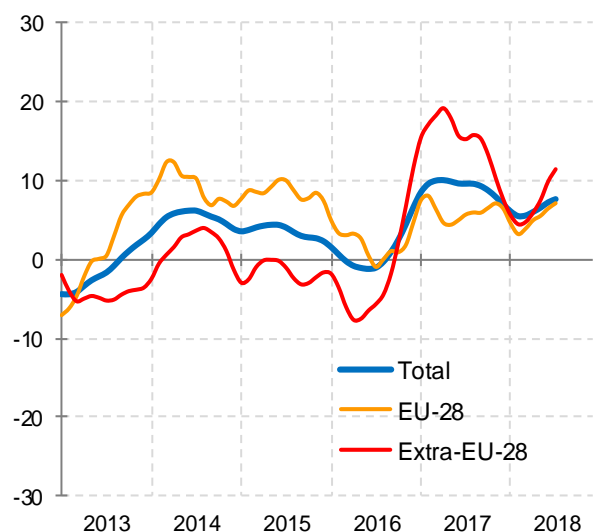


Imports from the **European Union** amounted to 52.2% of total imports in July 2018 (down from 54.2% in July 2017) and increased by 9.5% year-on-year. Imports from the **euro area** represented 42.5% (down from 43.9% in July 2017) and went up by 9.8%. Imports from **non-EU countries** accounted for 47.8% of total imports in July 2018 (up from 45.8% in July 2017) as they expanded by 18.6% year-on-year.

Exports EU and extra-EU (% y-o-y trend-cycle)



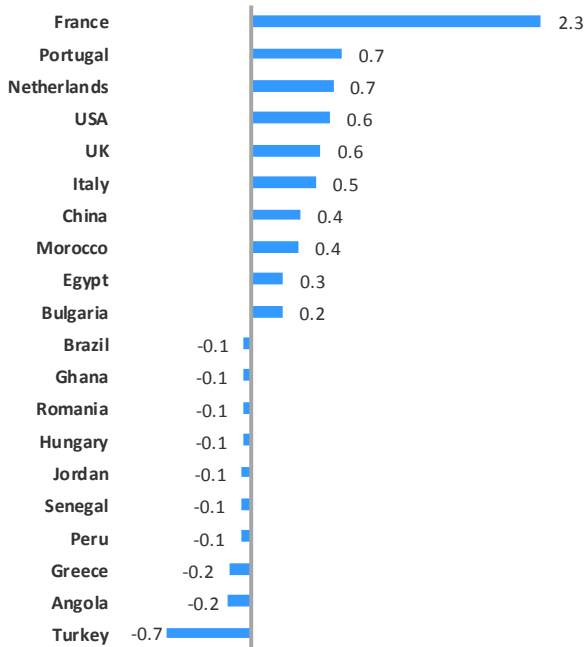
Imports EU and extra-EU (% y-o-y trend-cycle)



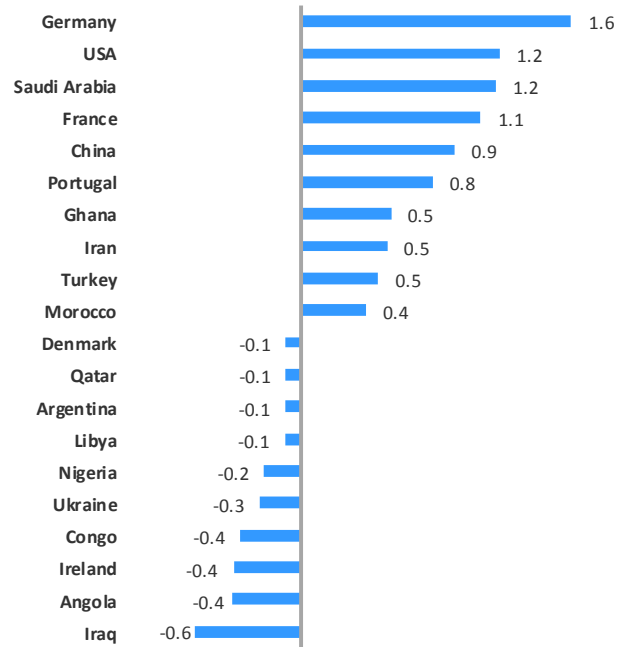
**Trade balance with the European Union** showed in July 2018 a surplus of 1,054.9 million euros (up from a surplus of 942.7 million in July 2017) and a surplus of 437.8 million euros with the euro area (444.7 million surplus in July 2017). **Trade deficit with the rest of the world** increased to 4,302.6 million euros (from a deficit of 3,041.5 million euros in July 2017).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in July 2018 (up by 9.8%) were France (2.3 percentage points), Portugal (0.7 points), the Netherlands (0.7 points) and the United States (0.6 points). Those destinations with the largest negative contributions were Turkey (-0.7 points), Angola (-0.2 points), Greece (-0.2 points) and Peru (-0.1 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in July 2018 (up by 13.6%) were Germany (1.6 percentage points), the United States (1.2 points), Saudi Arabia (1.2 points) and France (1.1 points). The destinations with the largest negative contributions were Iraq (-0.6 points), Angola (-0.4 points), Ireland (-0.4 points) and the Congo (-0.4 points).

### International data

**In comparison to other geographical areas**, Spain's exports of goods grew by 9.8% year-on-year in July, a higher increase than those of the euro area (9.4%) and the European Union (9.0%). Within the European Union, exports also increased in Germany (7.6%), France (13.9%), Italy (6.8%) and in the United Kingdom (5.4%). Outside the European Union, the United States exports advanced by 9.3%, China's by 12.2% and Japan's by 3.9%.



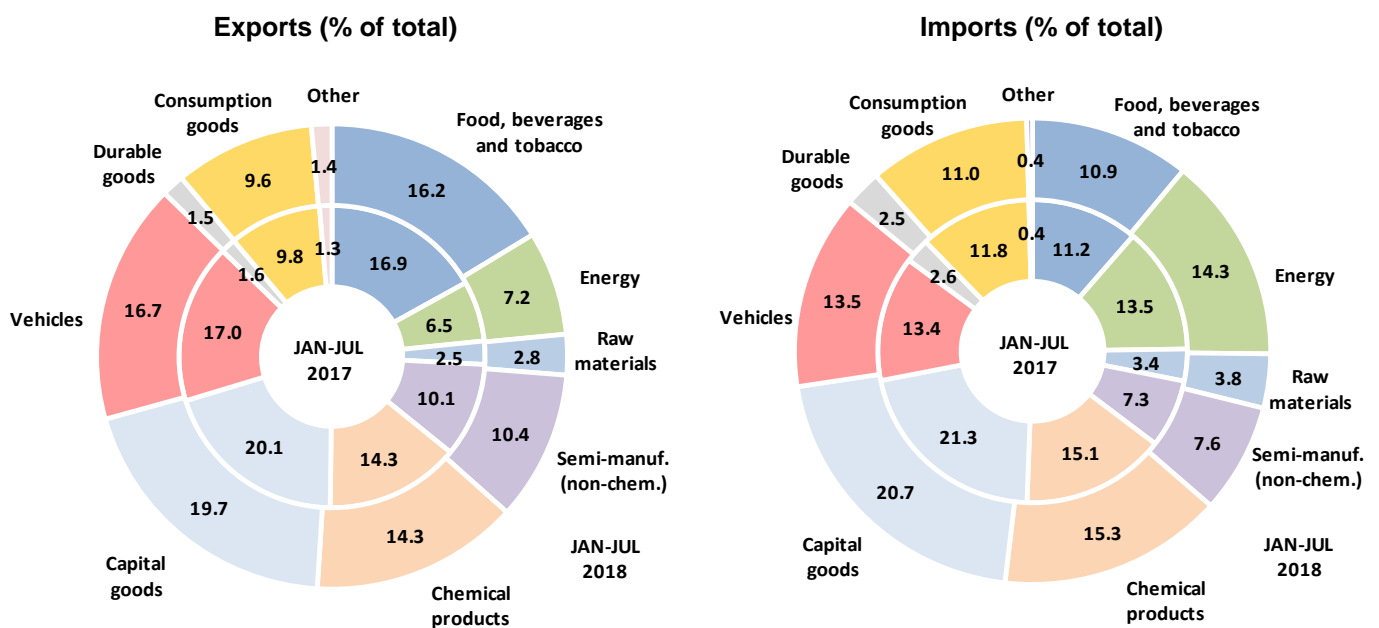
## JANUARY – JULY 2018

**Spain's exports expanded by 3.8%** in the period of January-July 2018 compared to the same period of 2017 to 169,271.3 million euros, and imports grew by 6.2% year-on-year to 187,104.2 million euros. In real terms, exports augmented by 1.0% year-on-year, as export prices increased by 2.8%, and imports rose by 2.7% year-on-year, as import prices advanced by 3.4%.

**Spain's trade deficit** increased to 17,832.9 million euros compared to the same period of 2017 (deficit of 13,187.1 million euros). The export/import **coverage ratio** reached 90.5%, 2.0 percentage points lower than in the same period of 2017 (92.5%, provisional data). The **non-energy trade balance** reached a deficit of 3,362.1 million euros, compared to a surplus of 87.6 million euros in January-July 2017, and the **energy trade deficit** expanded by 9.0% year-on-year to 14,470.9 million euros.

### Sectoral data

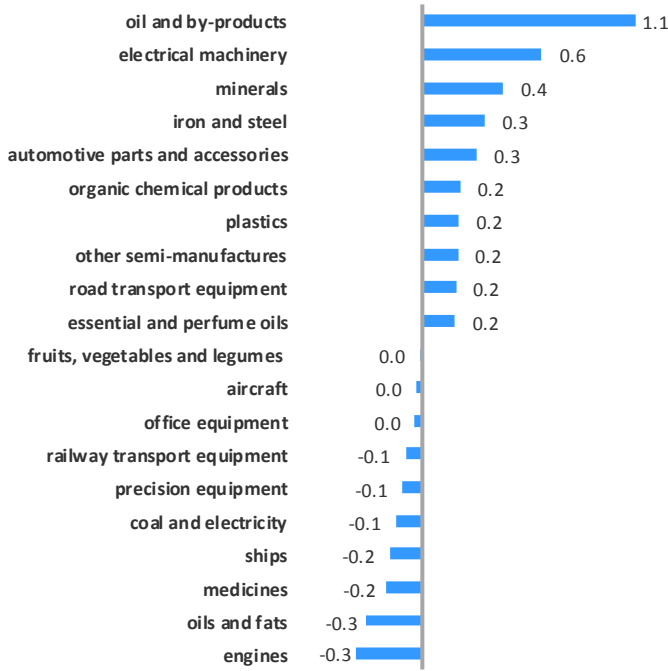
Spain's **main exporting sectors** in the period of January-July were *capital goods* (representing 19.7% of total exports, rising by 1.6% year-on-year), *vehicles* (16.7% of total, growing by 2.0%), *food, beverages and tobacco* (16.2% of total, declining by 0.2%) and *chemical products* (14.3% of total, increasing by 4.2%).



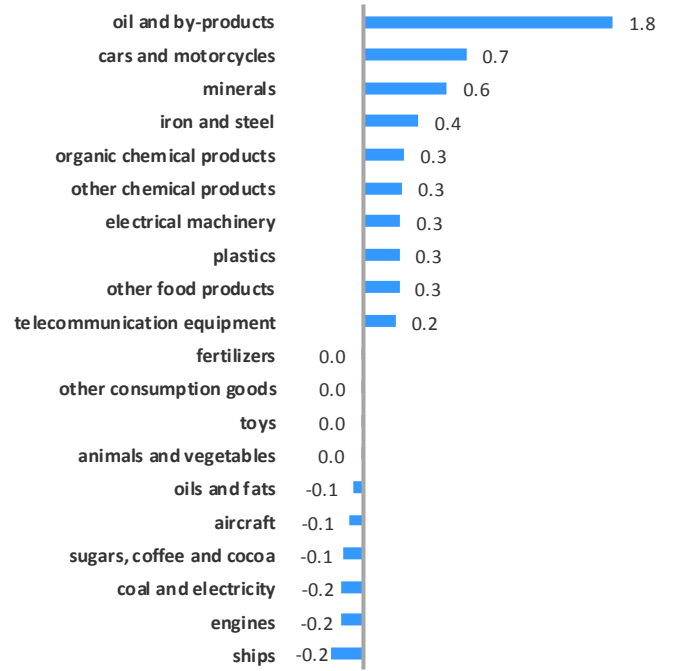
The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 20.7% of total and advancing by 3.1% year-on-year), *chemical products* (15.3% of total imports, growing by 7.5%), *energy* (14.3% of total imports, surging by 12.2%) and *vehicles* (13.5% of total imports, rising by 7.2%).

Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 3.8%) were *oil and by-products* (1.1 percentage points), *electrical machinery* (0.6 points) and *minerals* (0.4 points). On the other hand, the major negative contributions by subsectors corresponded to *engines* (-0.3 points), *oils and fats* (-0.3 points) and *medicines* (-0.2 points).

**Exports (top/bottom contrib. to annual change, p.p.)**



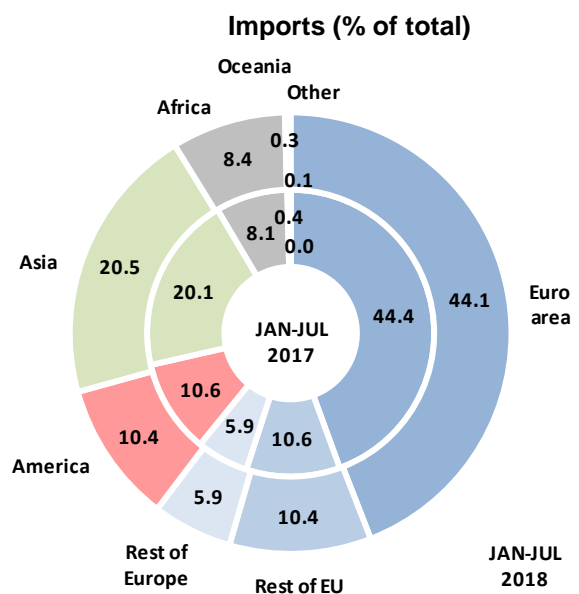
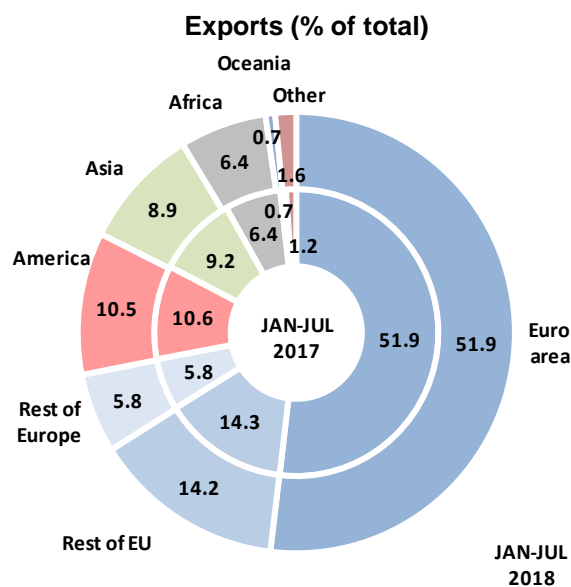
**Imports (top/bottom contrib. to annual change, p.p.)**



The **subsectors with the most positive contributions** to the annual change in Spain's **imports** in January-July 2018 (up by 6.2%) were *oil and by-products* (1.8 points), *cars and motorcycles* (0.7 points) and *minerals* (0.6 points). The major negative contributions corresponded to *ships* (-0.2 points), *engines* (-0.2 points) and *coal and electricity* (-0.2 points).

**Geographic data**

Exports to the **European Union** represented 66.1% of total exports in the period (down from 66.2% in the same period of 2017) and expanded by 3.7% year-on-year, and exports to the **euro area** ran at 51.9% of total (same value in identical period of 2017) and increased by 3.9%. Exports to the **rest of the world** amounted to 33.9% of total exports (33.8% in the same period of 2017) and grew by 4.1% year-on-year.



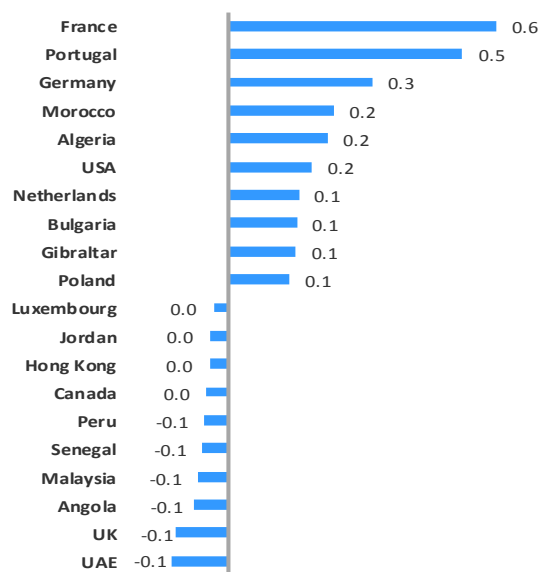
Imports from the **European Union** accounted for 54.5% of total imports in January-July 2018 (down from 55.0% in the same period of 2017) and advanced by 5.1% year-on-year. Imports from the **euro area**

amounted to 44.1% (44.4% in the same period of 2017) and expanded by 5.3%. Imports from the **rest of the world** ran at 45.5% of total imports (45.0% in the same period of 2017) and went up by 7.4% year-on-year.

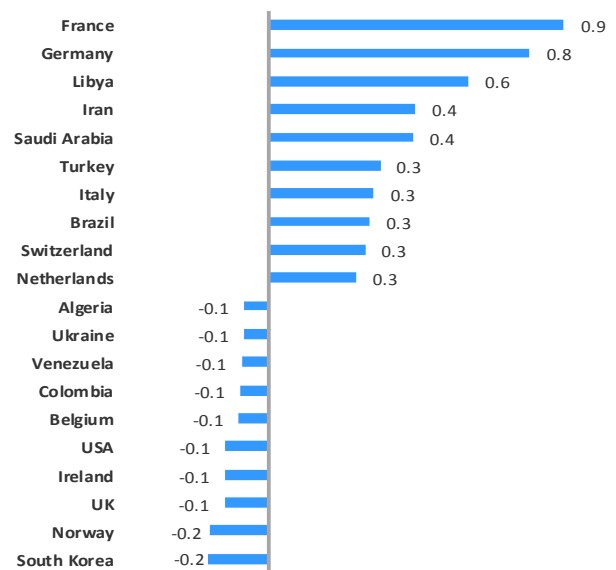
**Spain's trade surplus with the European Union and with the euro area** decreased to 9,946.1 million euros and to 5,361.9 million euros respectively, down from surpluses of 10,973.2 million and 6,272.2 million euros in the same period of the previous year. The **trade deficit with the rest of the world** advanced by 15.0% year-on-year to 27,779.0 million euros.

In terms of **contribution to the annual change of exports** (up by 3.8%), the main contributions were those of France (0.6 percentage points), Portugal (0.5 points), Germany (0.3 points) and Morocco (0.2 points). Those destinations with the largest negative contributions were the United Arab Emirates (-0.1 points), the United Kingdom (-0.1 points), Angola (-0.1 points) and Malaysia (-0.1 points).

#### Imports (top/bottom contrib. to annual change, p.p.)



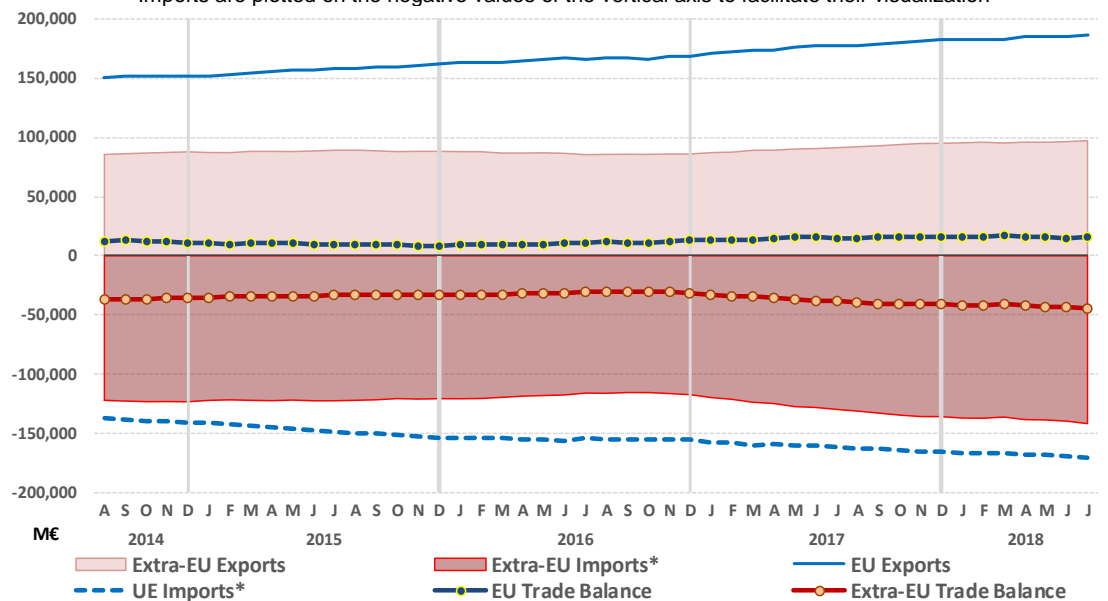
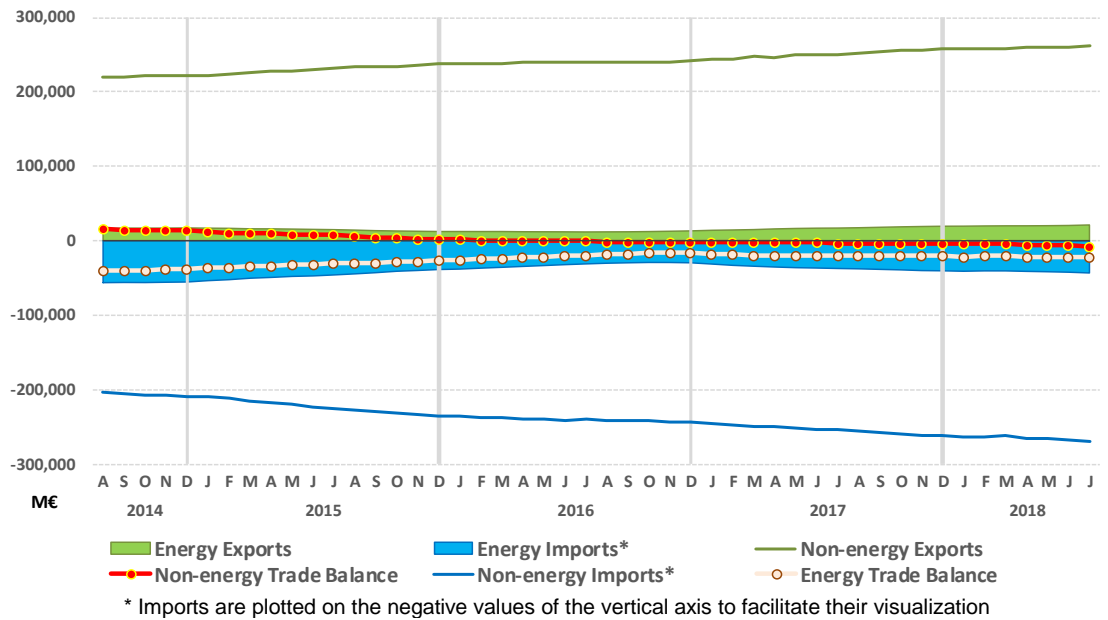
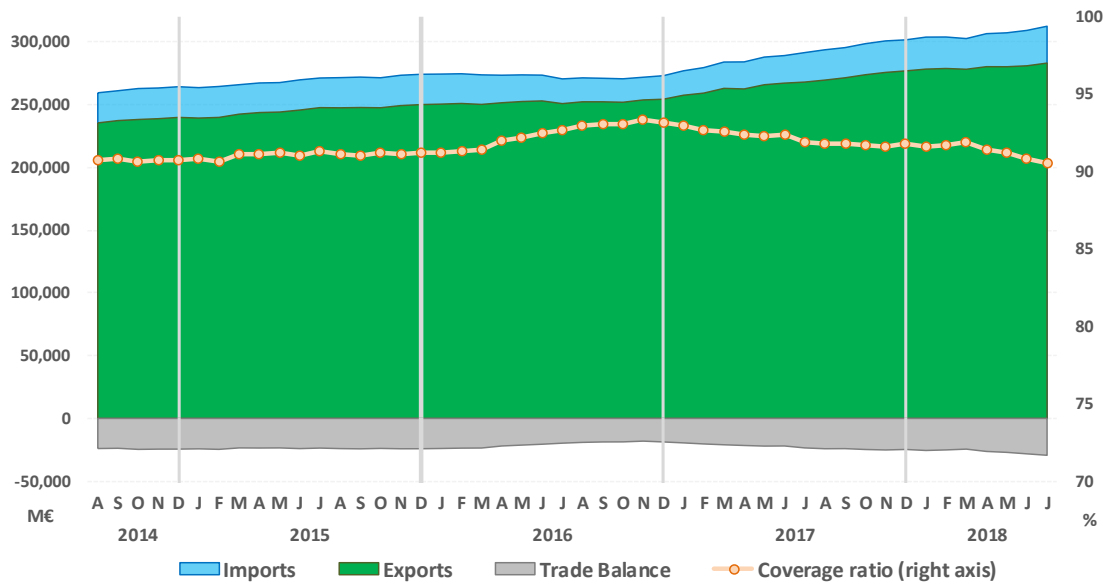
Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's imports in the period (up by 6.2%) were France (0.9 percentage points), Germany (0.8 points), Libya (0.6 points), and Iran (0.4 points). The destinations with the largest negative contributions were South Korea (-0.2 points), Norway (-0.2 points), the United Kingdom (-0.1 points) and Ireland (-0.1 points).

In the period January-July, the number of **Spanish exporters** increased to 149,268 exporters, out of which 32,339 had already exported at least 50,000 euros worth of goods in the period, 1.0% less than in the same period of 2017. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 49,086 in the period, 32.9% of total exporters and 2.2% more than in the same period of 2017. Their exports reached 162,349.0 million, 95.9% of total exports and 4.5% more than in the same period of the previous year.

### International data

**In comparison to other geographical areas**, Spain's exports of goods advanced by 3.8% year-on-year in the period of January-July 2018, a lower rate than those attained by the euro area and the European Union (4.9% in both cases). Within the European Union, exports also increased in Germany (4.5%), France (4.6%), Italy (4.2%) and the United Kingdom (4.7%). Outside the European Union, the United States exports augmented by 9.6%, China's by 12.6% and Japan's by 5.9%.
