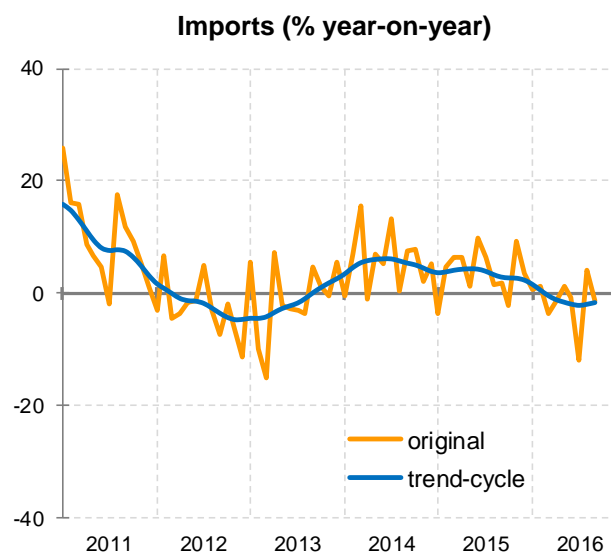
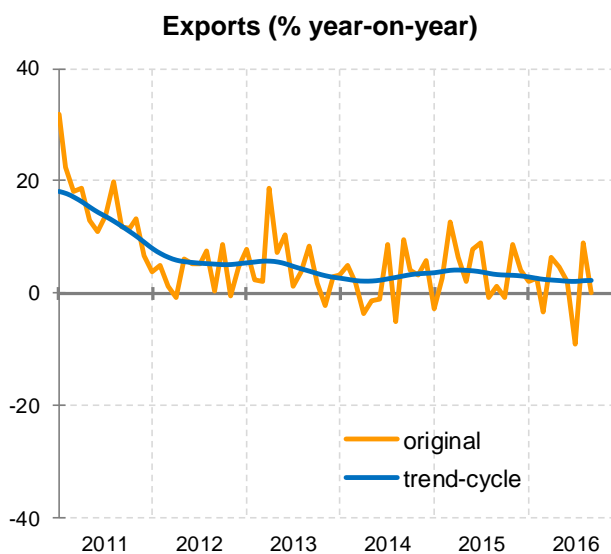

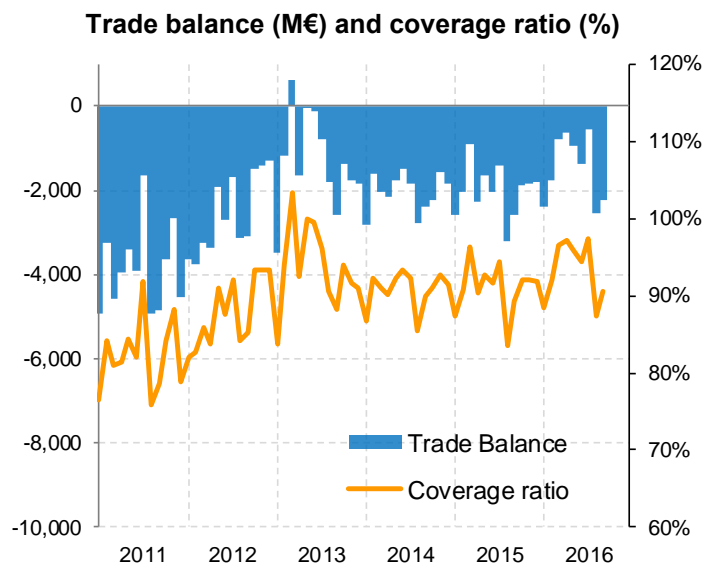


## SEPTEMBER 2016

In September 2016, **Spain's exports remained stable** in nominal terms (0.0% year-on-year) at 21,431.6 million euros, whereas **imports dropped by 1.4%** to 23,662.4 million euros. With seasonally adjusted data, exports fell by 0.7% year-on-year and imports by 2.2%. In **real terms**, exports grew by 0.2% year-on-year, as export prices shrank by 0.2%, and imports increased by 0.3%, as import prices declined by 1.7%. In nominal terms on a **month-on-month** basis, exports advanced by 21.5% and imports expanded by 17.1%. With seasonally adjusted data, exports decreased by 0.9% month-on-month and imports by 0.6%.

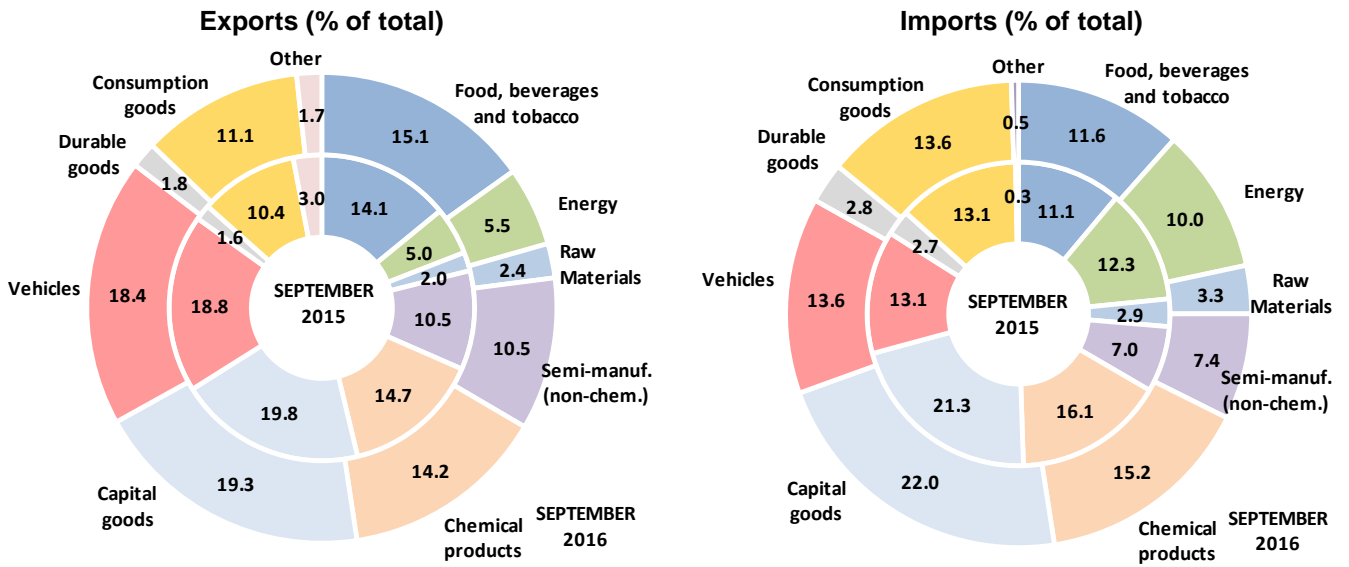


Spain's **trade balance** registered a deficit of 2,230.8 million euros, down from a deficit of 2,571.0 million euros in September 2015 (provisional data). The export/import **coverage ratio** reached 90.6%, 1.3 percentage points higher than in the same month of 2015 (89.3% in September 2015 with provisional data). The **non-energy trade balance** reached a deficit of 1,021.9 million euros, from a deficit of 704.1 million in the same month of 2015. The **energy trade deficit** fell by 35.2% year-on-year to 1,208.9 million euros (compared to a deficit of 1,866.8 million euros in September 2015).



### Sectoral data

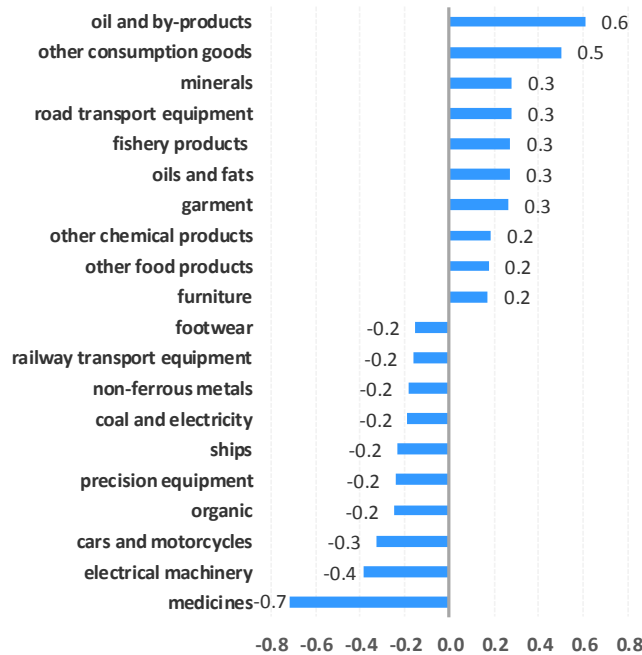
Spain's **main exporting sectors** in September 2016 were *capital goods* (representing 19.3% of total exports and diminishing by 2.5% year-on-year), *vehicles* (18.4% of total, shrinking by 2.1%), *food, beverages and tobacco* (15.1% of total, increasing by 7.5%) and *chemical products* (14.2% of total, declining by 3.5%).



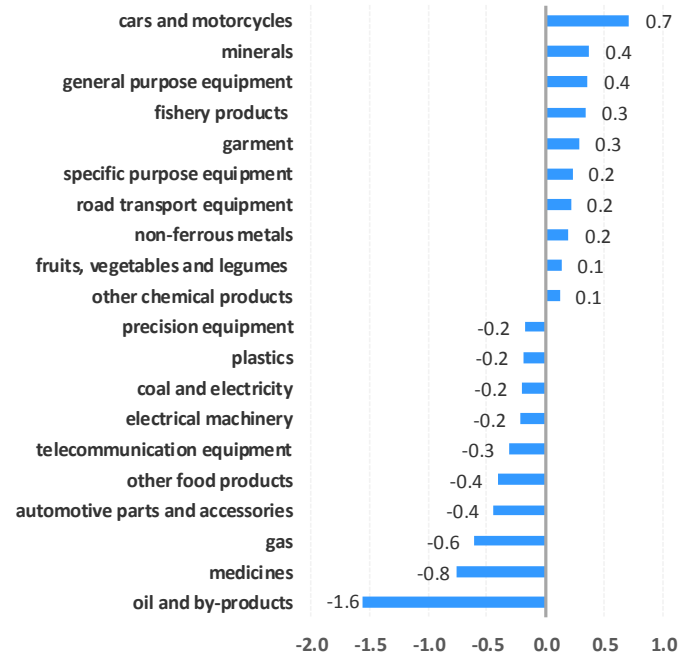
The most significant sectors of Spain's imports were *capital goods* (representing 22.0% of total imports and surging by 1.6% year-on-year), *chemical products* (15.2% of total, shrinking by 7.0%), *consumption goods* (13.6% of total, rising by 2.8%) and *vehicles* (13.6% of total, rising by 2.1%).

Among subsectors, the largest contributions to the annual change in Spain's exports in September 2016 (0.0%) came from *oil and by-products* (0.6 points), *other consumption goods* (0.5 points) and *minerals* (0.3 points). The major negative contributions corresponded to *medicines* (-0.7 points), *electrical machinery* (-0.4 points) and *cars and motorcycles* (-0.3 points).

Exports (top/bottom contrib. to annual change, p.p.)



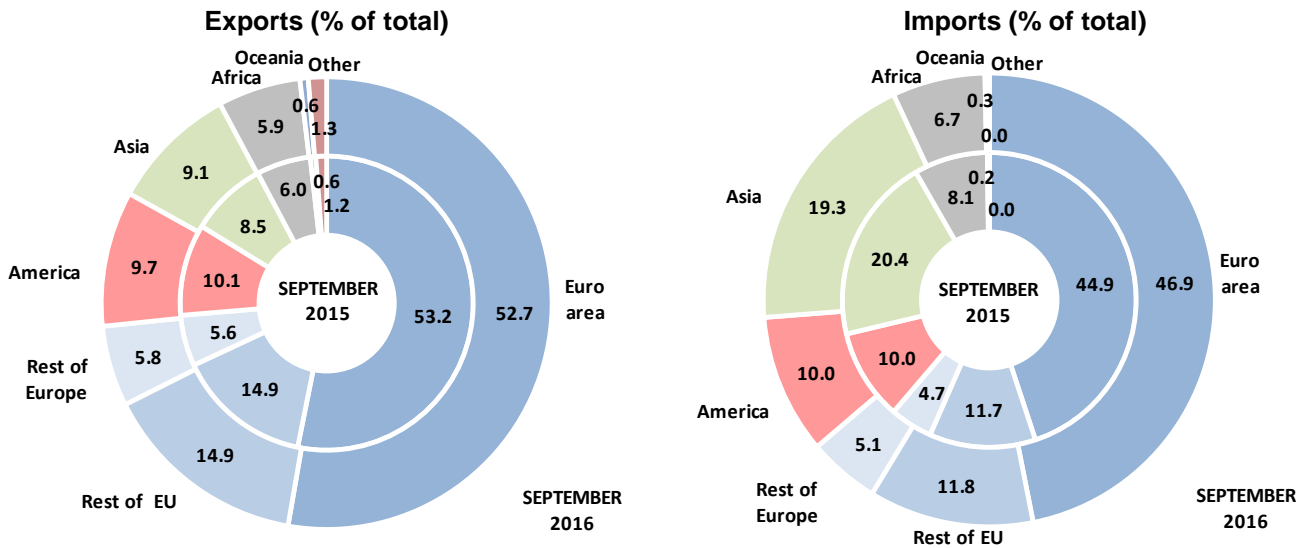
Imports (top/bottom contrib. to annual change, p.p.)



The subsectors with the most positive contribution to the annual change in Spain's imports in September 2016 (down by 1.4%) were *cars and motorcycles* (0.7 points), *minerals* (0.4 points) and *general purpose equipment* (0.4 points). The major negative contributions corresponded to *oil and by-products* (-1.6 points), *medicines* (-0.8 points) and *gas* (-0.6 points).

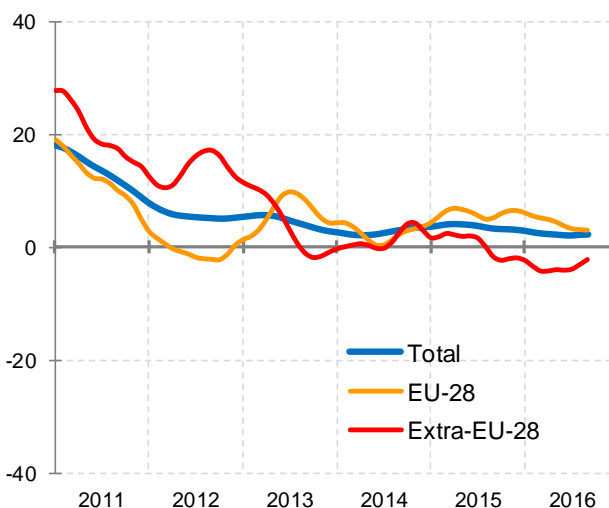
## Geographic data

Exports to the **European Union** accounted for 67.6% of total exports in September 2016 (down from 68.1% in September 2015) and dropped by 0.6% year-on-year. Exports to the **euro area** accounted for 52.7% (down from 53.2% in September 2015) and shrank by 0.8%. Exports to **non-EU countries** accounted for 32.4% of total exports (up from 31.9% in September 2015) as they advanced by 1.5% year-on-year.

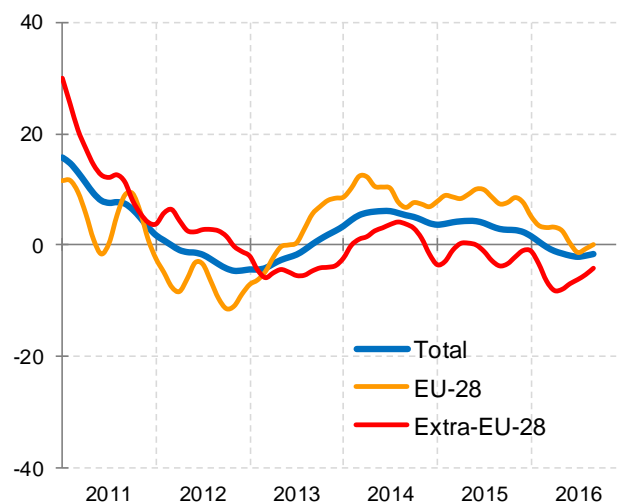


Imports from the **European Union** accounted for 58.7% of total imports in September 2016 (up from 56.6% in September 2015) and advanced by 2.2% year-on-year. Imports from the **euro area** represented 46.9% (up from 44.9% in September 2015) and grew by 2.9%. Imports from **non-EU countries** accounted for 41.3% of total imports in September 2016 (down from 43.4% in September 2015) as they fell by 6.1% year-on-year.

Exports EU and extra-EU (% y-o-y trend-cycle)



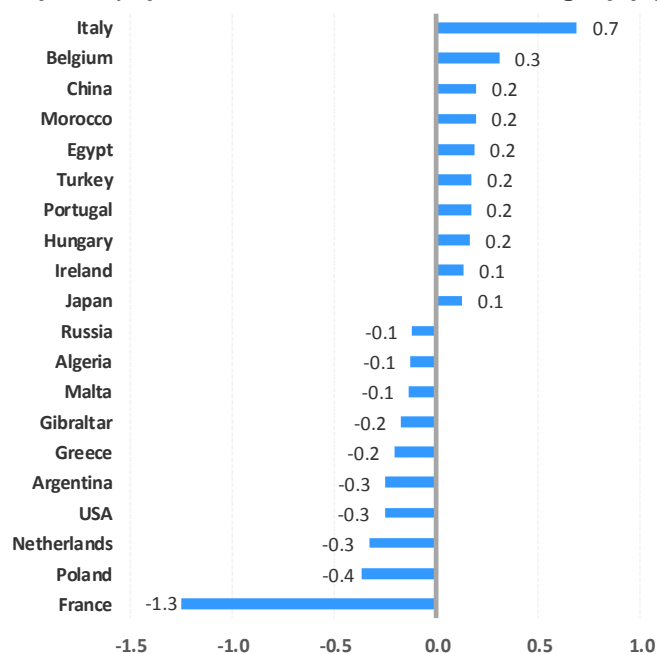
Imports EU and extra-EU (% y-o-y trend-cycle)



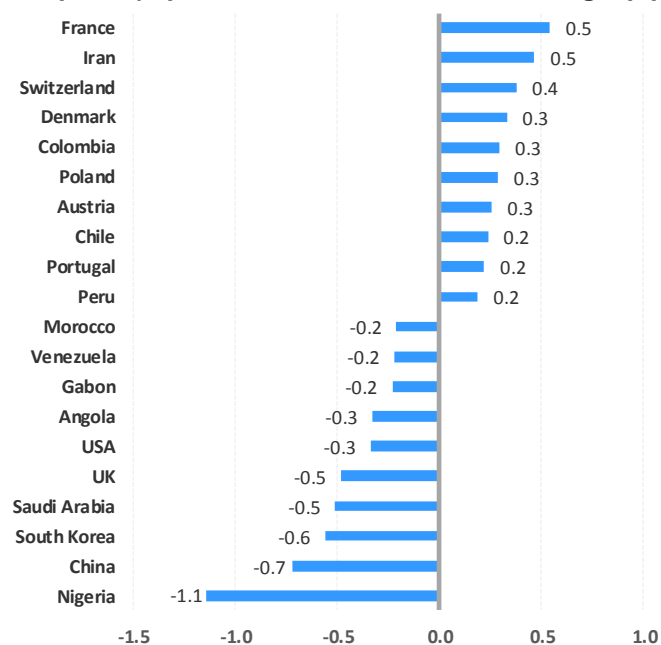
**Trade balance with the European Union** showed in September 2016 a surplus of 601.8 million euros (down from a surplus of 999.8 million in September 2015) and a surplus of 211.6 million euros with the euro area (616.1 million surplus in September 2015). **Trade deficit with the rest of the world** decreased to 2,832.6 million euros (from a deficit of 3,570.8 million euros in September 2015).

The **destinations with the largest contributions** to the annual change in Spain's **exports** in September 2016 (0.0%) were Italy (0.7 percentage points), Belgium (0.3 points), China (0.2 points) and Morocco (0.2 points). Those destinations with the largest negative contributions were France (-1.3 points), Poland (-0.4 points), the Netherlands (-0.3 points) and the United States (-0.3 points).

Regarding **imports**, the **countries with the largest contributions** to the annual change in Spain's **imports** in September 2016 (down by 1.4%) were France (0.5 percentage points), Iran (0.5 points), Switzerland (0.4 points) and Denmark (0.3 points). The destinations with the largest negative contributions were Nigeria (-1.1 points), China (-0.7 points), South Korea (-0.6 points) and Saudi Arabia (-0.5 points).

### International data

**In comparison to other geographical areas**, Spain's exports of goods remained stable in September (0.0% year-on-year), in contrast to the increase in the euro area (1.0%) and the fall in European Union (-0.5%). Within the European Union, exports also increased in Germany (0.9%) and Italy (3.1%), while they fell in France (-2.0%) and in the United Kingdom (-1.2%). Outside the European Union, the United States exports decreased by 0.2%, China's by 10.2% and Japan's by 6.9%.



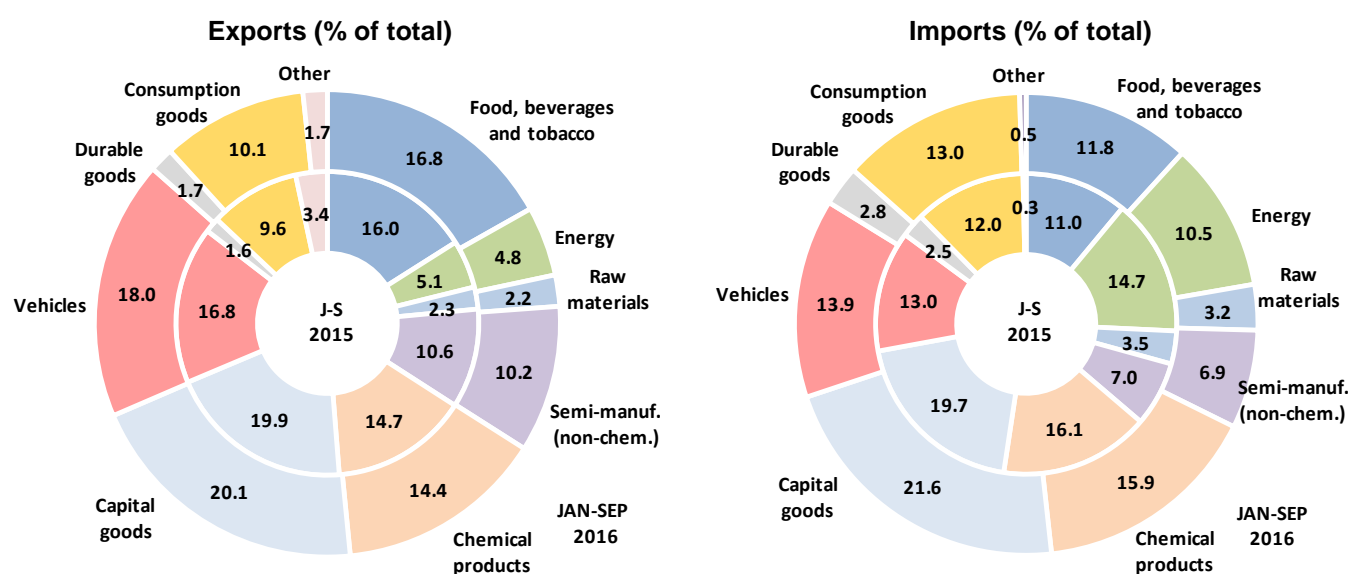
## JANUARY – SEPTEMBER 2016

**Spain's exports grew by 1.2%** in the period of January-September 2016 compared to the same period of 2015 to 188,485.2 million euros, whereas imports declined by 1.6% year-on-year to 201,712.3 million euros. In real terms, exports rose by 3.2% year-on-year, as export prices shrank by 2.0%, and imports augmented by 2.7% year-on-year, as import prices diminished by 4.2%.

**Spain's trade deficit** decreased to 13,227.1 million euros compared to the same period of 2015 (deficit of 18,642.0 million euros). The export/import **coverage ratio** reached 93.4%, 2.5 percentage points higher than in the same period of 2015 (90.9%, provisional data). The **non-energy trade balance** reached a deficit of 1,177.9 million euros, compared to a surplus of 2,034.1 million euros in January-September 2015, whereas the **energy trade deficit** declined by 41.7% year-on-year to 12,049.2 million euros.

### Sectoral data

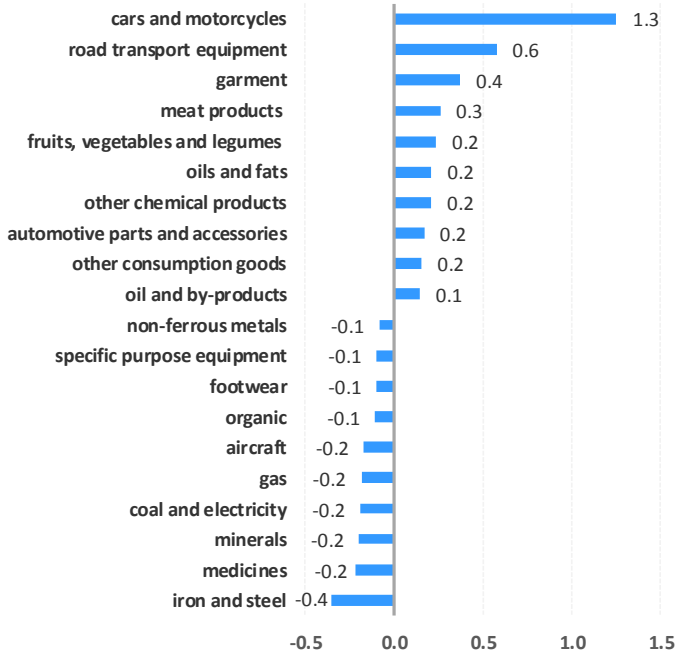
Spain's **main exporting sectors** in the period of January-September were *capital goods* (representing 20.1% of total exports, rising by 2.2% year-on-year), *vehicles* (18.0% of total, growing by 8.5%), *food, beverages and tobacco* (16.8% of total, growing by 6.2%) and *chemical products* (14.4% of total, diminishing by 0.4%).



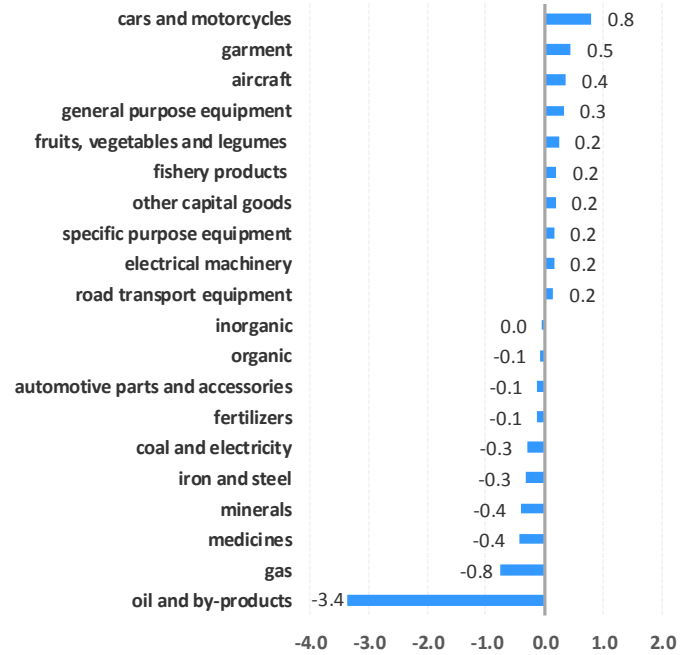
The **largest shares by sector of Spain's imports** were those of *capital goods* (representing 21.6% of total and growing by 8.0% year-on-year), *chemical products* (15.9% of total imports, declining by 2.8%), *vehicles* (13.9% of total imports, rising by 5.3%) and *consumption goods* (13.0% of total imports, rising by 6.2%).

Among **subsectors**, the largest contributions to the annual change in Spain's **exports** (up by 1.2%) were *cars and motorcycles* (1.3 percentage points), *road transport equipment* (0.6 points) and *garment* (0.4 points). On the other hand, the major negative contributions by subsectors corresponded to *iron and steel* (-0.4 points), *medicines* (-0.2 points) and *minerals* (-0.2 points).

**Exports (top/bottom contrib. to annual change, p.p.)**



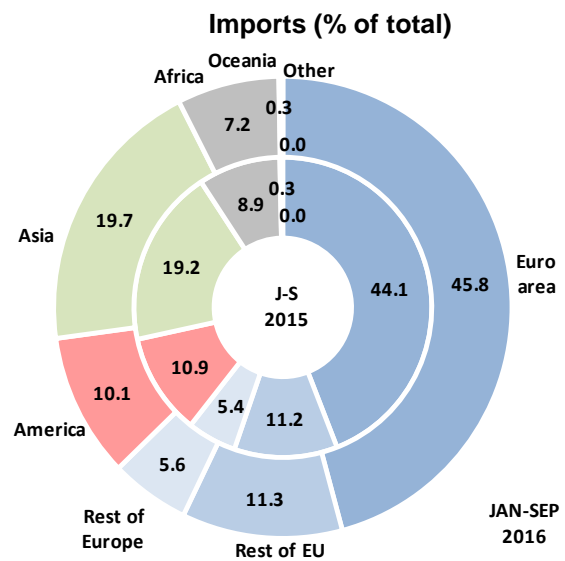
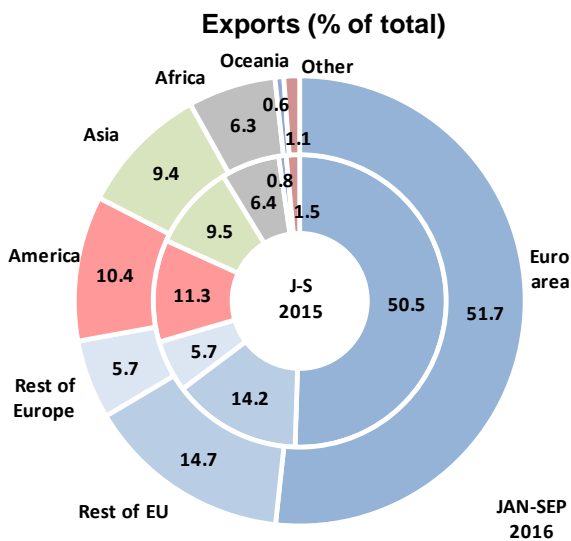
**Imports (top/bottom contrib. to annual change, p.p.)**



The **subsectors with most positive contributions** to the annual change in Spain's imports in January-September 2016 (down by 1.6%) were *cars and motorcycles* (0.8 points), *garment* (0.5 points) and *aircraft* (0.4 points). The major negative contributions corresponded to *oil and by-products* (-3.4 points), *gas* (-0.8 points) and *medicines* (-0.4 points).

**Geographic data**

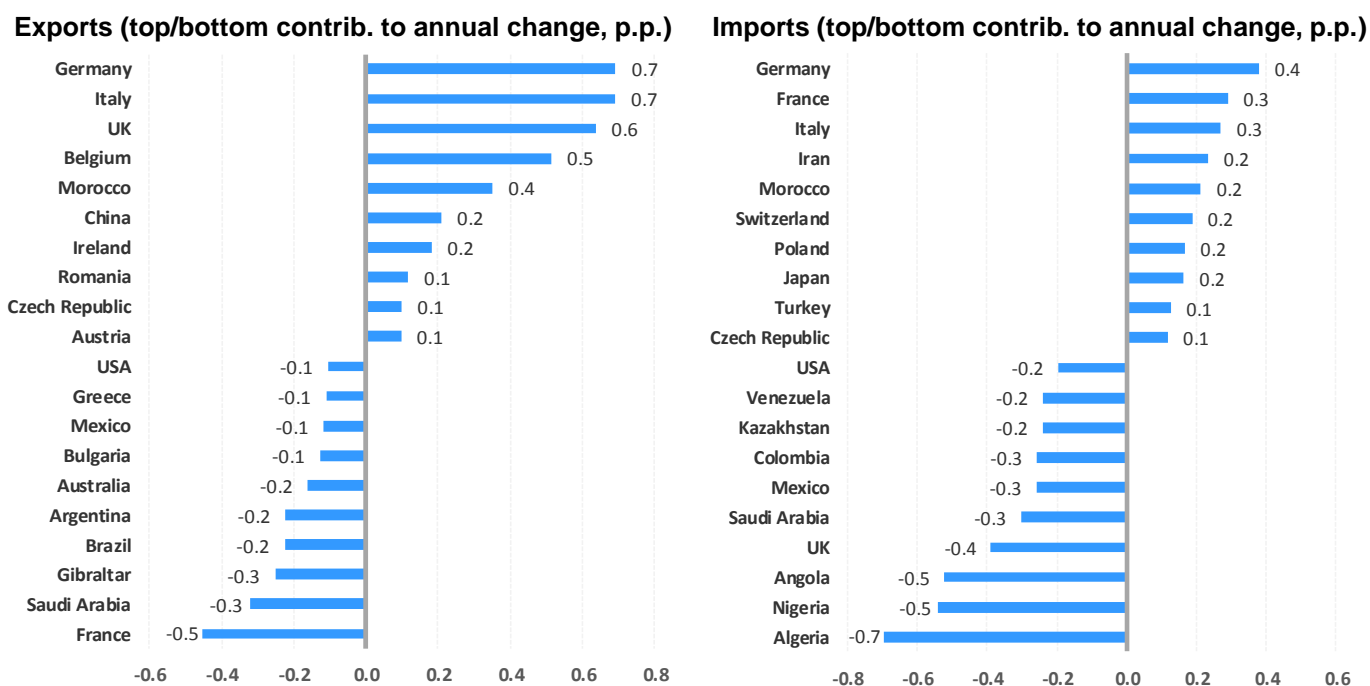
Exports to the **European Union** accounted for 66.5% of total exports in the period (up from 64.7% in the same period of 2015) and grew by 3.9% year-on-year, while exports to the **euro area** accounted for 51.7% of total (50.5% in the same period of 2015) and grew by 3.6%. Exports to the **rest of the world** accounted for 33.5% of total exports (35.3% in the same period of 2015) and declining by 3.8% year-on-year.



Imports from the **European Union** accounted for 57.2% of total imports in January-September 2016 (up from 55.3% in the same period of 2015) and grew by 1.8% year-on-year. Imports from the **euro area** accounted for 45.8% (44.1% in the same period of 2015) and grew by 2.3%. Imports from the **rest of the world** accounted for 42.8% of total (44.7% in the same period of 2015) and shrank by 5.7% year-on-year.

**Spain's trade surplus with the European Union and with the euro area** increased to 9,970.0 million euros and to 5,068.9 million euros respectively, up from surpluses of 7,276.8 million and 3,766.3 million euros in the same period of the previous year. The **trade deficit with the rest of the world** decreased by 10.5% year-on-year to 23,197.1 million euros.

In terms of **contribution to the annual change of exports** (up by 1.2%), the main contributions were those of Germany (0.7 percentage points), Italy (0.7 points), the United Kingdom (0.6 points) and Belgium (0.5 points). Those destinations with the largest negative contributions were France (-0.5 points), Saudi Arabia (-0.3 points), Gibraltar (-0.3 points) and Brazil (-0.2 points).



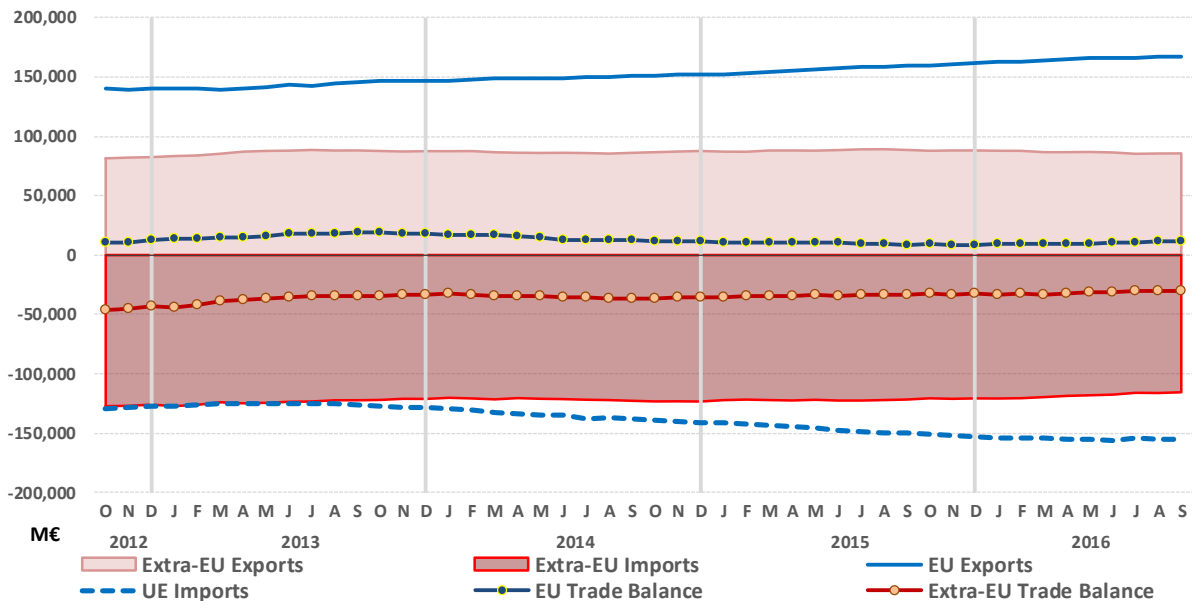
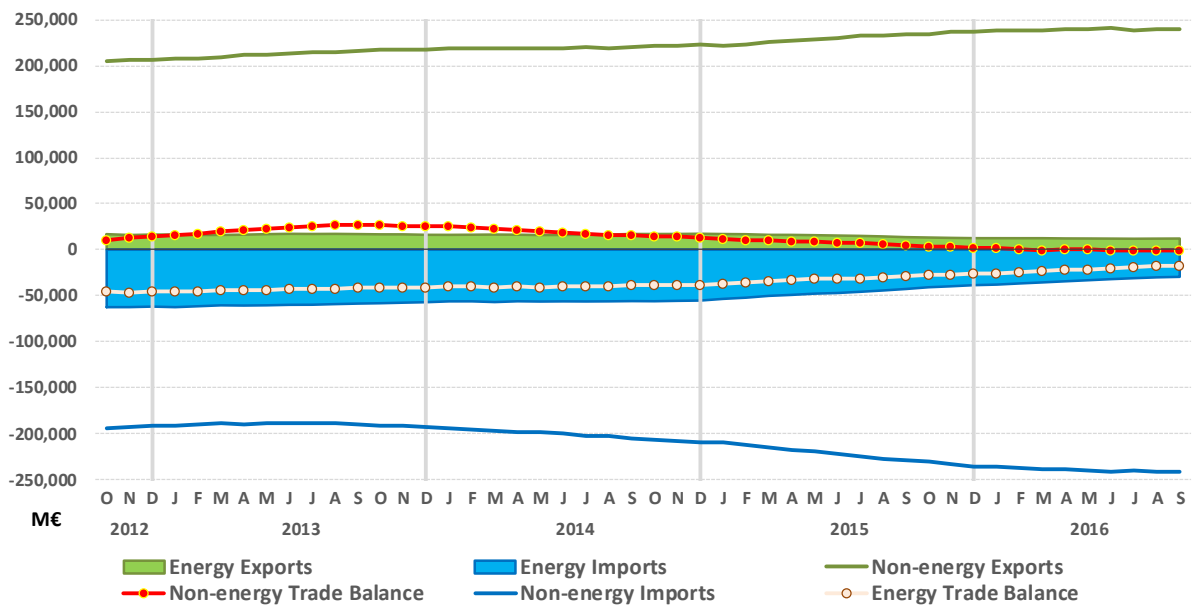
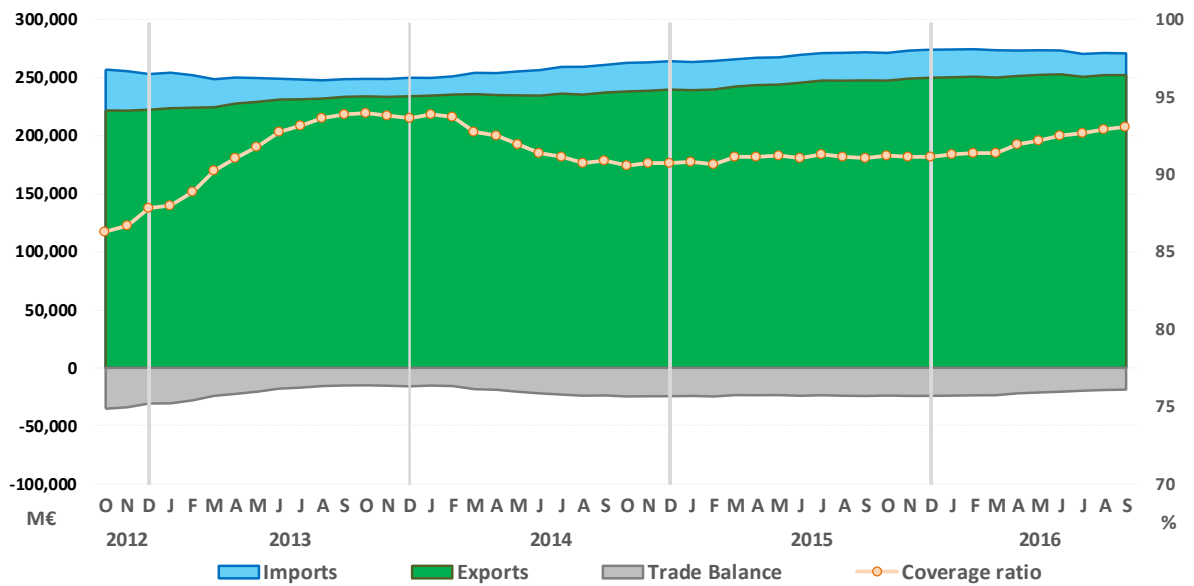
Regarding **imports**, the **countries with the largest contribution** to the annual change in Spain's imports in the period (down by 1.6%) were Germany (0.4 percentage points), France (0.3 points), Italy (0.3 points), and Iran (0.2 points). The destinations with the largest negative contributions were Algeria (-0.7 points), Nigeria (-0.5 points), Angola (-0.5 points) and the United Kingdom (-0.4 points).

In the period January-September, the number of **Spanish exporters** grew by 1.7% year-on-year to 126,747 exporters, out of which 34,733 had already exported at least 50,000 euros worth of goods in the period, 0.2% less than in the same period of 2015. With regard to regular exporters (those that have already exported in the current year as well as in each of the three preceding years), they amounted to 48,358 in the period, 38.2% of total exporters and 4.4% more than in the same period of 2015. Their exports reached 178,366.7 million, 94.6% of total exports and 2.3% more than in the same period of the previous year.

## International data

**In comparison to other geographical areas**, Spain's exports of goods grew by 1.2% year-on-year in the period of January-September 2016, a higher rate than those attained by the euro area (0.0%) and the European Union (-0.9%). Within the European Union, exports also increased in Germany (1.0%) and Italy (0.5%), while they fell in France (-1.5%) and in the United Kingdom (-4.3%). Outside the European Union, the United States exports decreased by 5.0%, China's by 6.8% and Japan's by 9.2%
